As discussed, Unici Casa must be aware of what they are approved for at each event, as well as, any additional conditions as required by the Police Department, Fire Department, Planning Department, and/or Engineering Department. Going forward, all Unici Casa events must include amplified sound.

Sgt. Irwin explained to Unici Casa that the Special Event Permit does not trump the municipal code or the penal code, and any further complaints can file a private person arrest in which Unici Casa would be issued a citation.

Chairperson Wolfberg stated that all applications must be submitted before any advertising goes out, with the specific activity of the event. Going forward, all Special Event Permits issued to Unici Casa will be copied to the Police Department, Fire Department, and Code Enforcement.
