BACKGROUND/DISCUSSION

During the April 26, 2022 regular meeting, the Equity and Human Relations Advisory Committee (EHRAC) created the Public Events Ad Hoc Subcommittee to plan public events for fiscal year 2022-2023 and to appoint members thereto. The EHRAC appointed Chair Rebecca Rona and committee members Haifaa Moammar and Samia Bano to this Ad Hoc Subcommittee.

The EHRAC has held various public events in fiscal year 2021-2022 and would like to continue to hold public events in the new fiscal year of 2022-2023. The public events in fiscal year 2022-2023 will also include the postponed events from the 2021-2022 fiscal year that were carried over to the new fiscal year.

The Public Events Ad Hoc Subcommittee will discuss the proposed events outlined in their report that are planned for fiscal year 2022-2023 with the entire EHRAC to receive feedback and approval of their recommendations.

Incorporating Courageous Conversations

Subcommittee members <u>encourage</u> those planning events to consider incorporating "Courageous Conversations into the event" when feasible and appropriate.

We envision Courageous Conversations as dialogue-focused events (or portions of events) where attendees will have the opportunity to:

- 1. Participate in facilitated dialogue about critical issues related to equity and human relations
- 2. Learn and practice the skills needed to use the Equity and Human Relations Avisory Committee's recommended Civil Discourse Guidelines

Strengthening Civil Discourse Skills

Even when people agree in principle with the idea of engaging in civil discourse, they can struggle to actually implement the guidelines during high-stakes and/or already heated conversations. Therefore it would be valuable for the Committee to create safe/brave spaces where our community members can practice and strengthen their civil discourse skills.

Professional Trainer

During an event that incorporates Courageous Conversations, a professional trainer could assist the audience to practice a particular civil discourse skill, such as a specific deep listening technique, or a specific technique to respond to charged comments. Participants

would practice in small groups or pairs by engaging in dialogue with each other. Participants would be provided a topic such as transgender rights, or disability justice, or preventing the abuse of seniors.

Popular events of the past

We recommend that the Committee sponsor certain popular events, such as the Indigenous Peoples Day Celebration, and the Asian American Storytelling Program, not this fiscal year but possibly every other year to enable the Committee to schedule events in a given year that have not been sponsored in the past.

Other marginalized people

We recommend that in the coming year and in ensuing years, some of our events focus on such marginalized people as seniors, children, Muslims and Jews, people with mental health challenges, people with physical disabilities/ "challenges," and others.
