3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 CULVER CITY, CALIFORNIA, APPROVING AN
5 APPLICATION FOR GRANT FUNDS FROM THE HABITAT
6 CONSERVATION FUND PROGRAM FOR THE CULVER
7 CITY NATURE TRAIL REHABILITATION PROJECT.

8 WHEREAS, the people of the State of California have enacted the California
9 Wildlife Protection Act of 1990, which provides funds to the State of California for grants to
10 local agencies to acquire, enhance, restore or develop facilities for public recreation and
11 fish and wildlife habitat protection purposes; and

12 WHEREAS, the State Department of Parks and Recreation has been
13 delegated the responsibility for the administration of the Habitat Conservation Fund (HCF)
14 Program, setting up necessary procedures governing project application under the HCF
15 Program; and

16 WHEREAS, said procedures established by the State Department of Parks
17 and Recreation require the applicant to certify by resolution the approval of the application
18 before submission of said application to the State; and

19 WHEREAS, if the application is approved by the State Department of Parks
20 and Recreation, the City of Culver City will enter into a contract with the State of California
21 to provide funds for the Culver City Nature Trail Rehabilitation Project (the "Project").

22 NOW, THEREFORE, the City Council of the City of Culver City DOES
23 HEREBY RESOLVE:

24 1. The filing of an application with the State Department of Parks and
25 Recreation for Habitat Conservation Program Funds for the Project is hereby
26 approved; and

27 2. The City of Culver City hereby certifies that it has or will have
28 available, prior to the commencement of any work on the Project included in this
application, the required match and sufficient funds to complete the Project; and

1 3. The City of Culver City hereby certifies that it has or will have sufficient
2 funds to operate and maintain the Project; and

3 4. The City of Culver City hereby certifies that it has reviewed,
4 understands, and agrees to the provisions contained in the contract shown in the
5 Grant Administration Guide; and

6 5. The City of Culver City hereby agrees to comply with all applicable
7 federal, state and local laws, ordinances, rules, regulations and guidelines; and

8 6. The City Council hereby appoints the City Manager, or his designee, to
9 conduct all negotiations, and to execute and submit all documents including, but not
10 limited to, applications, agreements, amendments, payment requests and so forth,
11 which may be necessary for the completion of the aforementioned project.
