Mayor O'Brien offered to work with the Pilates Studio to remediate the unexpected denial of the grant.

Appeal of the Planning Commission's Decision to Adopt Resolution No. 2024-P007, Approving Conditional Use Permit Modification, P2021-0135-CUP/M and a Class 32 Categorical Exemption from the California Environmental Quality Act (CEQA) for the Relocation and Expansion of an Existing Costco Fueling Station at 13431-13463 Washington Boulevard

MOVED BY COUNCIL MEMBER VERA, SECONDED BY VICE MAYOR PUZA AND UNANIMOUSLY CARRIED, THAT THE CITY COUNCIL: RECEIVE AND FILE THE AFFIDAVITS OF MAILING, PUBLISHING AND POSTING OF PUBLIC NOTICE.

Gabriela Silva, Associate Planner, provided a summary of the material of record.

MOVED BY COUNCIL MEMBER VERA, SECONDED BY VICE MAYOR PUZA AND UNANIMOUSLY CARRIED, THAT THE CITY COUNCIL OPEN THE PUBLIC HEARING.

Mayor O'Brien invited public comment.

The following members of the public were called to speak:

Beller, representative of Appellant, expressed appreciation for thoughtful consideration by the City Council; presented a video that expressed concern with the risks of benzene exposure to children noting the proximity of the proposed gas station to preschools and the increased capacity; expressed concern with not being able to quarantee a safe environment for the children; presented a video calling on Costco to cease and desist the action or at least conduct an environmental assessment to prove to them that the community and children would not be put in harm's way; he noted that the children were dependent on adults and elected officials to protect them; asserted that they were sensitive receptors and particularly vulnerable to the benzene that would be put into the environment; he acknowledged the desire of Costco to improve member experience but he did not think it should come at the experience of the community and neighboring preschools; took issue with the term modification as an entirely new gas station is being proposed; and he asked that an EIR (Environmental Impact Report) be performed to assure them that the children were in a safe environment.

Dale Goldsmith, Applicant, Land Use and CEQA (California Environmental Quality Act) Counsel for Costco, expressed agreement with the conclusion of the staff report and the City's independent experts that the appeal is without merit; he discussed potential health risks to the preschool operating out of a home without necessary zoning approvals; the extensive environmental analysis including an HRA (Health Risk Assessment); consideration of relevant pollutants and age sensitivity factors; the analysis and conservative assessment indicating less than significant impacts; issuance of the permit

from the South Coast Air Quality Management District (SCAQMD); the request for an EIR; rigorous studies already conducted and independently reviewed that would be included in an EIR; placing demands on the limited resources of staff; the gas station on the site since 1999; development of a new state of the art facility to reduce queues, improve circulation, provide for more efficient operations, and improve member experiences; sales tax revenue generated for Culver City; furthering Culver City's environmental initiatives by including 20 fast EV chargers for public use while providing additional bicycle parking for members and employees; scrutiny of the project by City staff; and he asked that the City Council follow Planning Commission approval of the project and the staff recommendation to deny the appeal.

Stephen Jones reiterated the vote for an environmental review that he made when the item came before the Planning Commission; he discussed City Council discretion; deviation from the normal rule to assume vacant storefronts are vacant and not drawing traffic; previous Costco gas station expansions that have resulted in a large increase in car trips; and he asked the City to deny the exemption and not to let the threat of a lawsuit deter the City from protecting the people.

Jocelyn Finger provided background on herself; indicated that she could not imagine how the project would not have a significant environmental impact; discussed current traffic levels; leaking benzene fumes; and she asked that the needs of the residents and small children adjacent to the proposed site be put before the needs of the corporation.

Eve Rappoport indicated living adjacent to the site; urged the City Council to accept the appeal from Sol y Luna; pointed out a letter submitted by the neighbors outlining the many concerns presented to the Planning Commission; acknowledged that the consultants had done what was acceptable to analyze the project; noted that some of the conclusions did not make sense; expressed concern with allowing a Conditional Use Permit (CUP) on an EIR that was done over 25 years ago; discussed changes to the area; concern with doubling the size of the gas station and moving it closer to a residential area without examining the EIR and rescinding the CUP; methods for calculating trip generation indicating that no extra trips would be involved; and she asked the City Council to read the other letter.

James Muir reported living next to the facility; discussed changes to the neighborhood since Costco moved in; common sense;

traffic backups; concern with bringing more traffic into an already impacted area; traffic from In and Out; backups on to Washington Boulevard; Costco loading docks; freight trucks and employee parking; idling cars; landscaping that attracts homeless people; he asserted that Costco was not a good neighbor; and he hoped that the appeal would be properly considered and supported.

Alba Beller with one minute ceded by Jordan Reisenweber, owner and Director of Sol y Luna Montessori Preschool, reported that she and her children lived there; she felt that they were not being unreasonable in requesting a new environmental assessment; and she noted that a new assessment was the responsible thing to do.

Luna Beller was called to speak but declined to speak.

Indy Beller was called to speak but declined to speak.

Adam Bice discussed being a parent of a Sol y Luna alumnus; the positive experience; building community; concerns about the proposed expansion; the need for a full and transparent review to make sure that the project is truly safe; core pillars that many Council Members were elected on including accountability, accessibility, support for small businesses, transparency over special interests, progressive transit, sustainable development, and deepening community engagement; he urged the City Council to uphold their commitments; discussed prioritizing the health of the community rather than corporate convenience; choosing the future over fossil fuels; and keeping Culver City's values strong.

Kate Pletcher indicated being a member of the community and a huge fan of Costco; expressed concern about the project and language used by the lawyer about slowing the project down and causing unnecessary expense; statements about location of the gas station; the fundamentally different gas station that they are proposing; and she asked that the City Council support the appeal.

Erik Pletcher echoed comments from previous speakers; indicated spending a lot of time at the Beller home every week; felt that the big decision should err on the side of resident safety; and he wanted to see the City Council require the environmental study.

Sean Silva spoke on behalf of the Office of Los Angeles City

Council Woman Tracy Park in support of the appeal; felt that review beyond a categorical exemption from CEQA was warranted; requested that impacts of the proposed project that will spill into Los Angeles be studied; and expressed appreciation for consideration of the issue.

Pooya Goudarzi indicated living directly next to the property line where Costco wants to move the gas station and being the parent of twins; provided background on himself and his experience; questioned how the project that moves a major VOC (Volatile Organic Compound) source next to family homes could ever be considered exempt from environmental review; noted that their neighborhood was one of the few R1 zones that has been surrounded by commercial usage; discussed urban design; factors ignored when granting the exemption; turning a blind eye toward environmental and planning principles as well as to residents; he urged the City Council to deny the exemption and require a full EIR; and he asked the City to protect their children, homes, and health.

Phoebe Kiekhofer Garfinkel expressed appreciation for being heard; asked the City Council to deny the request for an environmental exemption for the gas station and its relocation; noted that it was widely known that gas stations cause cancer; discussed the California Air Resources Board recommendation against gas stations near residences or other sensitive receptors such as a preschool; ignoring impacts to traffic and air quality; quality of life issues; she stated that every Costco expansion had resulted in more car trips; felt that the City should not be approving the project; inconsistency with the General Plan; discussed singling out the neighborhood for environmental justice issues; ensuring that the commitment is being kept to the young people of the City who cannot speak for themselves; and she expressed concern with putting the needs of a corporation above the health needs and quality of life for young people.

Paula McCredie, former Costco employee, noted that she lives on Walnut Avenue; discussed previous comments by a Costco representative about moving the project to the LA side so they did not have to do more; green building; moving a gas station to within 200 feet of homes; and she felt that green building should be upheld for everyone, including Los Angeles.

Dale Goldsmith (Applicant), AGD, reiterated that studies conducted for the project are the exact same studies as are done with an EIR; he stated that the exemption was not a shortcut;

discussed length of time they had been working on the project; length of the report; key information provided to enable the project to move forward; concerns expressed about VOCs and benzene; findings indicating that the emissions would be below applicable thresholds of significance; traffic studies; the nonlinear increase in traffic; less than significant impacts determined in the noise, traffic and air quality analyses; trips from current members; efforts to address the existing queues; use of conservative assumptions that resulted in a determination of no significant CEQA or non-CEQA impact based on Level of Service; trip credit; the peer reviewed response to the appeal; less than significant project transportation impacts even without the credit; new traffic counts taken by Gibson Traffic consultants; and examination of the school impacts that proved to be less than significant.

Discussion ensued between Mr. Goldsmith, staff, and Council Members regarding the difference between the EIR and the reports that were done; alternative projects; limits to the amount of fuel than can be pumped on an annual basis; and physical distance between the current site and the proposed site.

Frank Angel, (Appellant) counsel for Sol y Luna, noted the lack of a mention in any of the information provided that the project is located in the only state EPA (Environmental Protection Agency) identified disadvantaged community in Culver City and in one of two environmental priority neighborhoods under (Senate Bill) SB 1000; discussed CalEPA census tract rankings for pollution; the reason Costco is avoiding CEQA; avoiding public accountability and alternatives; perpetuating a environmental injustice for a community already exposed to higher pollution burdens than the rest of California; the slanted and incomplete health analysis; the need for CEQA mandated accountability; he asserted that the City Council must reverse the Planning Commission's approval of the project; discussed improper reliance of the CUP on the exemption and reliance on the previous General Plan that did not include an environmental justice component; the project that runs counter to elements and policies of the new General Plan; the need to find that the project is consistent with all applicable General Plan objectives and policies and with the objectives of the state of California in order to approve the exemption; the exemption allowing avoidance of inter-agency consultation pursuant to CEQA; denial of the CUP modification with the inability to make the findings of consistency with the new applicable General Plan; and he noted the Culver City had stood up to Sentinel and they could stand up to this project.

MOVED BY COUNCIL MEMBER FISH, SECONDED BY VICE MAYOR PUZA AND UNANIMOUSLY CARRIED, THAT THE CITY COUNCIL CLOSE THE PUBLIC HEARING.

Discussion ensued between staff and Council Members regarding appreciation to those who spoke to share their valid concerns with risks to health; the need to do everything possible to ensure that children are protected from deeply harmful impacts; the CARB recommendation that gas stations are never approved near residences; concern with moving the gas station closer to residences in a pollution-burdened community; the intention of CEQA to assess the impact of projects on the community; concern with the argument that doubling the size of the gas station would not increase emissions; inconsistency with the General Plan; permitted uses; and support for asking staff to prepare their best case in favor of the appeal with information coming to the City Council for consideration.

Council Member Fish reported that he had refused support from the automotive and fossil fuel industries or any large corporate donors so that he could represent people over profits.

Additional discussion ensued between staff and Council Members regarding exploration of every possible route to protect residents; appreciation to staff and the community, and comments that pointed out the pollution burden borne by the neighborhood; sustainability goals of the General Plan; inconsistency of expansion of the fossil fuel industry with strategic guidelines for the City Council; notices posted when getting gas about the harmful nature of being near the receptors; the need to ensure people have the opportunity to thrive; and support for having staff prepare the best case approval for the appeal.

Further discussion ensued between staff and Council Members regarding General Plan goals being referenced that were not in effect when the Planning Commission took action on the CUP modification; looking at what was presented and what the City can and cannot do moving forward; checking the boxes and ensuring everything is in compliance; and support for moving forward with the decision of the Planning Commission.

Discussion ensued between staff and Council Members regarding appreciation to those who spoke, for the work of staff, and for the strong partnership with Costco; acknowledgement of the request for an EIR, transparency, and the desire for environmental protection and careful review for a project of

the scale being proposed; public trust, health, and environmental stewardship; the need for additional information; fear and concern being expressed; taking the opportunity to build trust between neighbors; and lack of harm with gathering more information with an EIR.

Additional discussion ensued between staff and Council Members regarding acknowledgement of concerns with the impact of new development on the environment; respect for the hard work done by staff; third party peer review of the study that was done and sponsored by the applicant; and trust in the work done.

Council Member Fish proposed a motion to remand the item to a future meeting with direction to staff to come up with the strongest argument using some of the points uplifted with regard to the new location and potential increase in car trips as a route for not concurring with the report.

Discussion ensued between staff and Council Members regarding concerns from Council Members about the traffic impacts with direction for staff to report back to the City Council as to whether that would be enough to take the item out of the realm of a Class 32 exemption; concerns about consistency with the General Plan and research into the arguments around the General Plan being applicable to the discussion; impacts related to traffic and queueing as well as potential health risks; the pollution-burdened community; the SB 1000 designation; consideration of the CEQA findings and the CUP; clarification that direction is to do an additional study to see what level of documentation is warranted; steps for CEQA review; and determination of what level of review if required.

MOVED BY COUNCIL MEMBER FISH AND SECONDED BY VICE MAYOR PUZA THAT THE CITY COUNCIL: CONTINUE THE ITEM TO A FUTURE MEETING WITH DIRECTION TO STAFF TO COME BACK WITH AN UPDATED RESOLUTION THAT CONSIDERS CONCERNS RELATED TO THE SB 1000 DESIGNATION, GENERAL PLAN CONSISTENCY, TRAFFIC QUEUEING, AND HEALTH RISKS RAISED BY MEMBERS OF THE PUBLIC IN THE VERBAL AND WRITTEN PUBLIC COMMENTS RELATED TO WHY THE FINDINGS SUPPORTING THE CLASS 32 EXEMPTION CANNOT BE MADE AND DIRECTION TO PREPARE AN EIR OR CONDUCT A STUDY TO DETERMINE WHAT LEVEL OF ENVIRONMENTAL REVIEW IS NEEDED.

Item A-1

CC - Consideration of an Entertainment Zone for Downtown Culver City and Provide Direction to the City Manager's Office as Deemed Appropriate

Luis Gonzalez, Economic Development Project Manager, provided a summary of the material of record.

Discussion ensued between staff and Council Members regarding determination of boundaries; management of entry and exit; establishing procedures; size of the area included; delineation and management of the logistics; safety concerns; concern with people walking into traffic; pairing the zone with open streets events; ensuring that people do not get hurt; specific events that street closures attached; law that requires consultation with public safety officials in all manner of issues that relate to alcohol and the public right of way; the process to work out details with the management plan; the requirement that the entertainment zone be revisited every two years in consultation with Public Safety; adjustments to maintain safety; potential additional costs to the City; preliminary estimates; and events that already require police officers.

Mayor O'Brien invited public comment.

The following members of the public addressed the City Council:

Darrell Menthe, Downtown Business Association (DBA), indicated that he had suggested bringing the item forward; provided background on establishment of entertainment zones; discussed allowing people to walk around an event with a drink in their hand; event requirements for entertainment zones; practices in the rest of the world; understanding how the process works; use for special events; and he hoped the City would support the item.

Jack Galanty discussed benefits to event entertainment zones in San Francisco; activating the downtown business district; Culver City Pride; safe consumption of alcohol; existing law; requirements against overserving; and he noted that there would not be open bars.

Melissa Sanders asked that Jack make his Halloween stuff available for more than one night; expressed support for the idea of an event entertainment zone; discussed benefits; the two-year trial; event suggestions; kiosks; being allowed to walk around and see things with your drink; and support for anything that helps downtown.

Kira Pusch expressed support for the proposed entertainment zone; discussed success in other cities; coupling events with open streets; safety; fully committing to the effort by closing the area to through traffic; enabling local businesses to spread out on to the sidewalk to serve more customers; and she encouraged the City Council to promote active transportation to and from the entertainment zones.

Leah Pressman wanted to ensure that the City did not pay extra costs to have an entertainment zone; discussed problems with drinking and driving; the fact that it is not puritanical to be concerned with safety; she noted that it was in the public interest for Culver City to encourage people to drink less, not more; discussed well-known negative impacts of alcohol consumption; concern with having a free-for-all zone; the small amount of taxes collected; and ensuring that safety is prioritized.

Denise Neal expressed support for finding a safe middle ground; noted that Culver City hosted the largest AA community in the nation on Wednesday nights; proposed providing better options such as mocktails; discussed allowing the right to choose; concern with liability; The Steps; an experience she had on July 4th; people who step out of bounds when they are intoxicated; serving alcohol in a gallery situation in the Helms District; keeping alcohol away from the stairs; having a wristband system to keep track of how many drinks a person receives; ensuring against serving under-age individuals; and people with sobriety issues.

Jeannine Wisnosky Stehlin expressed support for the proposed entertainment zone; discussed upcoming major events coming to Culver City; other cities that have successful programs; helping the downtown area thrive; creativity and community; allowing people to drink while attending special events; support for also allowing non-alcoholic events; the purpose of social events; and she expressed support for careful management and review of the proposed program.

Discussion ensued between staff and Council regarding appreciation for the public comment and for the work of staff; the opportunity to support small businesses downtown; providing fun experiences for upcoming world events; agreement with safety concerns; support for taking first steps to explore the possibility of an entertainment zone; concern with people being intoxicated and interacting in the public right of way; suggested events; pairing the map with open streets or in areas where there is not vehicle traffic; concern with people being injured while they are drinking; costs; the Olympics; support for allowing the business community to provide the fees necessary to support the program as they will reap the benefits; understanding the impact on the City; amount of taxes received by Culver City; and the need to generate \$850,000 to recoup the \$17,000 for the program.

Additional discussion ensued between staff and Council Members regarding new ways to support stakeholders in the community; programs piloted in other cities; the importance of safety; interest in the open streets aspect; engaging in a shared responsibility model; and curiosity to see more details moving forward.

Further discussion ensued between staff and Council Members regarding showing support for small businesses with the program; defeating the purpose by having small businesses pay for the program; helping small businesses rather than adding costs; revisiting the item in the future; moving forward without the Third Wednesday program; and revenue generated with the San Francisco program.

Discussion ensued between staff and Council Members regarding reimagining public space; creating a more vibrant, walkable downtown area; the pilot program that would be reviewed in two years; looking at having businesses pay for participation after evaluation of the program in two years; ensuring a low barrier for the pilot program; cost sharing; the safety component; the ability to adjust boundaries; clarification that only participating businesses would serve the alcohol; responsibility of the businesses for not overserving; consistent cups used for the program; holding a meeting before the event to tailor the event; the intent to support all the downtown businesses; providing a pathway for businesses that are not in the zone to still provide drinks that can go into the zone; the non-fenced in program; designation of the drinking zone; use of branded wristbands; facilities licensed by ABC (Alcoholic Beverage Control); similar programs in other cities; creating boundaries for each event; the responsibility of the businesses to create signage to designate where the events are; the partnership with CCPD; clarification that drinking establishments would not be added to the public right of way; the feeling that people might be less drunk because they are getting one drink and then walking around rather than sitting in one place and having many drinks; length of time other cities have been engaged in similar programs; feedback from Santa Monica that the program is going smoothly; confined open streets events in San Francisco; concern with the large size of the area; businesses that want to participate; a suggestion to allow for flexible boundaries depending on event design; a suggestion to start small for the pilot; and confining to the area to the streets closed to car traffic to ensure safety.

Mayor O'Brien moved to direct staff to move forward with the proposed concept and return with the necessary safety parameters included in the staff report to ensure a safe event.

Council Member Fish proposed a substitute motion to adopt the staff recommendation with flexible boundaries that can scale based on the design of the event to prioritize open streets areas for the entertainment zones. Council Member McMorrin seconded the motion.

Additional discussion ensued between staff and Council Members regarding collaboration with other departments; research indicating that design is a great way to keep people safe; concern that closing off Main Street would not prevent people from walking in the street; open boundaries wherever the flexible space is; lack of fencing required for the ABC license; previous issuance of alcohol use permits pursuant to ABC licensing to limit entrance to those over 21; the ability to require fencing in the management plan for entertainment zones; concern with additional costs by adding a fencing requirement and imposing restrictions prematurely; the ability to discuss matter further in the Economic Development Subcommittee; limiting crossing dangerous intersections to minimize risk; and concern with additional costs related to focusing events around open streets.

MOVED BY COUNCIL MEMBER FISH AND SECONDED BY COUNCIL MEMBER MCMORRIN THAT THE CITY COUNCIL: ADOPT THE STAFF RECOMMENDATION WITH FLEXIBLE BOUNDARIES THAT CAN SCALE BASED ON THE DESIGN OF THE EVENT TO PRIORITIZE OPEN STREETS AREAS FOR THE ENTERTAINMENT ZONES.

CC - (1) Discussion of Recommendations from the Sustainability Subcommittee to Regulate Single-Use Plastic Beverage Bottles, Balloons, Smoking, Single-Use Bags not Exempted by California Public Resources Code, and Astroturf; and (2) Direction to City Manager as Deemed Appropriate

Sean Singletary, Environmental Programs and Operations Manager, introduced the item.

Wallis Nash, Senior Management Analyst, provided a summary of the material of record.

Mayor O'Brien invited public comment.

The following members of the public addressed the City Council:

Craig Cadwallader, Surfrider Foundation, Ballona Renaissance (BCR), provided background on himself; discussed dismantling of regulations and protections at the federal level; the importance of taking a strong stand at the local level; concerns based on lack of knowledge; the need to educate the business community; assurance that the aim is not to harm businesses; the proposed ordinances that are based on other ordinances state-wide; items reviewed by staff; customer supplied reusables regulations; (Assembly Bill) AB 619; singleuse beverage container regulations; the large difference between plastic bottles and aluminum cans; distorted comments from big box wholesalers; efficiency; the weight of aluminum vs. the weight of plastic; infinitely recyclable items vs. downcycled items; micro-plastics; replacement of plastic beverage bottles with aluminum; providing waste receptacles in restaurants; take out regulations; compliance with AB 1276; creating a disposable beverage cup charge to encourage people to bring their own or use reusables; elimination of the significant environmental impact of balloons; extending (Senate Bill) SB 270 and SB 1053; adoption of the bag ban on December 6, 2022; elimination of designated smoking areas to make all outside public spaces smoke-free; and banning tobacco sales.

Council Member Vera indicated the need to recuse himself from the bag portion of the discussion and he exited the dais.

Responding to inquiry, Craig Cadwallader (BCR) discussed differences between the staff report and the recommendation from BCR; failure to mention that Los Angeles had adopted the bag ban in December of 2022 in the staff report; other cities that have adopted the ban; extension of the bag ban; and bags not covered by SB 270 and SB 1053.

Discussion ensued between staff and Council Members regarding the list of suggested amendments provided by BCR; the proposal from BCR to completely ban plastic bags in Culver City; and clarification that Los Angeles is modeling new state legislation but has not instituted a full ban of plastic bags.

Mayor O'Brien discussed procedures noting that Council Member Vera could hear public comment but could not be present for the Council deliberation on plastic bags.

Dan Morrical provided background on himself; discussed issues with plastics; predictions by the medical community of worsening problems with micro-plastics in children; the opportunity for Culver City to approve the proposed changes to reduce micro-plastics; efforts of previous generations to protect from tobacco, lead paint, and depletion of the ozone layer; concern with not making efforts to protect children from plastic; and he noted that it would undoubtedly take fatalities to get the necessary protections in place.

Leigh Martin, California Fuels and Communities Alliance, provided background on the organization; discussed potential harm to gas stations and convenience stores by the proposed restrictions; profit margins; revenue provided by plastic bottle sales; the reality of the beverage industry; increased expenses with the use of aluminum and glass; concern with driving customers to other cities; reduced tax revenue; and she expressed support for Option 4 that focuses restrictions on Culver City sponsored events and facilities rather than on retailers who serve the community.

Maria Stockham, Coalition for Responsible Celebration, provided background on the organization; expressed support for the proposed ban on intentional balloon releases; allowing for responsible celebration; the fact that 60% of balloon décor is used indoors with mostly air fill; opposition to broader balloon restrictions; unfairly burdening responsible small, minority, and women-owned businesses in Culver City; larger businesses; businesses that participate in local clean up; and the recent

clean up at Ballona Creek where no balloon trash was found, demonstrating that responsible practices work.

Myung-Soo Seok, Painters and LA Trades District Council 26, indicated being a representative of the union that represents installers of synthetic turf; expressed appreciation for comments from the BCR representative regarding the intention of bans and regulations to not eliminate jobs; noted that an outright ban of synthetic turf kills the jobs of the professional installers; appreciated the hard work put in by staff; discussed confusion about data and level of technology being used in the industry; discussed different types of synthetic turf; development of new materials; and other cities that began with a ban.

Jack Galanty expressed support for banning balloon sales noting that issues are seen in other cities; discussed his observations of balloons in the gutter; support for the ban on astroturf; airborne toxins; micro-plastics; support for the proposed ban on plastic bags; he noted that plastic bottles are one of the most widely used and trashed objects; and he stated that plastics are not recyclable in the ways distributed in prior years.

Jennifer Silberman was called to speak but was not present online or in Council Chambers.

Dr. Mimi Nartey (document provided to Council), provided background on herself; thanked Culver City for their leadership and continued commitment to sustainability; asked that artificial turf be considered separately from other plastics; noted that single-use plastics are short-lived consumer waste while astroturf is a part of public health infrastructure creating safe, enduring, and dignified access to recreation; discussed under-resourced neighborhoods; providing reliable spaces for young people to move their bodies and build confidence; the lived reality of children who already have less; public health benefits of maintaining access to play spaces; consistent exercise as reducing the risk of cancer; and unintentionally increasing health risks.

Doug Krauss indicated being an Environmental Programs Manager from a beach city; provided insight from an agency that had implemented a similar code; stated that the changes were not only doable, but imperative; discussed other area cities that have passed similar ordinances; burden; costs; flexibility to enforce at their own space; different tools available; and he noted that the businesses had adapted.

Sandrine Cassidy, BCR, with one minute ceded by Leah Pressman, presented a video of a Culver City High School student describing looking at trash when riding along the Ballona Creek Bike Path every day and expressing support for the efforts made to clean things up and provide incentive for people to keep things clean; she provided background on BCR; discussed being stewards of the land; building upon bold steps to reduce plastic waste and protect Ballona Creek; money to fund studies, surveys and outreach to prepare the recommendations; progress delayed by industry opposition; she noted that industries always adapt; pointed out that every ordinance always included hardship exemptions, but no business had ever applied for them; asserted that claims of harm were not true; discussed the number of plastic bottles sold annually in Culver City; the power of local ordinances that shape the future; and she asked the City Council to adopt all the Options 1.

Candance Pilgram-Simmons provided background on herself; indicated speaking on behalf of small retailers; noted her support for sustainability but concern with the scope, timing, and impact on large and small businesses; discussed the quarter cent sales tax; her experience with the Green Business Certification Program; the amount of time, education, activation necessary to make real change; cost differences; gradual changes made; she asked the City Council to lead with collaboration rather than enforcement and to incentivize sustainability rather than penalizing businesses; discussed phasing in restrictions thoughtfully; refraining implementation of costly changes; removing income streams from small businesses by banning the sale of plastic bottles; and she asked to move forward together.

David Coles was called to speak but was not present online or in Council Chambers.

Melissa Sanders indicated being a huge proponent of the environment but being exhausted with constant revenue-negating things brought forward by the City Council; discussed wasting time by taking away revenue from the City; support for banning smoking areas; felt that people should be allowed to choose whether or not to use astroturf or bring in recyclable containers; discussed the message being sent to Costco; looking at things that will actually help the City and bring people in;

and putting things on the people who shop, eat, and work in Culver City.

Wailele Sallas indicated being a small business owner and resident; expressed appreciation for the commitment to sustainability goals; discussed concern with unintended consequences; real issues being considered by the City; overreach; enforcement options; concern with people of color being disproportionately targeted at outdoor gatherings; reputational impacts to Culver City; focusing resources on environmental education rather than enforcement; similarities to the MOVE project from a few years ago; and he hoped that they would not risk creating economic strain, resentment, and the erosion of the City in the name of environmental progress.

Jeremy Bocchino, City Clerk, received confirmation that Council Member McMorrin, who was participating by teleconference, could still hear the proceedings.

Mayor O'Brien invited public comment.

The following members of the public addressed the City Council:

Brian Thomas, Costco, discussed their history in Culver City; their commitment to sustainability; concern with negative impacts to customers with the proposed plastic beverage bottle retail ban; beverages currently offered at the Culver City location; negative effects to consumption; and concern with

redirecting customers to make purchases in neighboring areas and cities.

Phoebe Kiekhofer Garfinkle was called to speak but was not present in person or online.

Grocers' Association, Tim James, California appreciation for the continued focus on sustainability; discussed looking at the entire landscape; the fee as resulting in a price increase for consumers during a difficult time for affordability; disadvantaging current Culver City grocers and discouraging future grocery investment; the ability for consumers to shop across City lines or rely more on online shopping; harm to Culver City-based businesses; the state government financial charge for environmental purposes on beverages called the California Redemption Value; deposits per container; the ability for local governments and NGOs (nongovernmental organizations) to apply for millions of dollars in support; the ability of consumers to purchase balloons online or in other cities; impacts to Culver City based brick and mortar retailers; and he asked that the City hold off on pursing recommendations until the full scope of the impacts are understood.

Kevin Lachoff with one minute ceded by Michele Lachoff, spoke as Vice Chair of the Culver City Chamber of Commerce, discussed a recent survey of Chamber members reflecting overwhelming opposition to being put at more of a competitive disadvantage; expressed support for education and incentives for businesses and consumers rather than enacting an outright ban; discussed the recent milestone of reaching 100 businesses being certified as Green Businesses; education to inspire and achieve changes; review of the work of the Sustainability Subcommittee; support for the general recommendations on bottles; encouragement to the City Council to determine costs of the climate initiatives referenced in the recommendation; fees; understanding financial impacts to make informed decisions; the phase in period for plastic bags; local business still recovering from challenging economic times; taking gradual approach; а competitiveness in mind; competition with businesses neighboring jurisdictions; adding more costs to goods in Culver City than Los Angeles; and concern with pushing consumers to shop elsewhere.

Denise Neal discussed creating a hardship with recycling; being more responsible; the need for very clear and visible signage to delineate non-smoking and vaping areas; impacts to people

with allergies; looking at which plastics are petroleum derived to provide a stream of income for Culver City; getting away from artificial astroturf; looking at the coconut derived or non-pellet astroturf; focusing on being more sustainable; exponential amounts of trash with the Olympics; the need for infrastructure to strategically sort trash; and creating biofuel from food waste.

Jeannine Wisnosky Stehlin discussed single-use plastic; enforcement; education and incentives; and she noted that speakers from the business community were asking for their concerns to be taken seriously.

Suzie Huddleston, Mayflower Distribution, provided background on the company; expressed support for the proposal to ban the intentional release of balloons; did not support broader restrictions on ballon use, materials, or fill; discussed unintentional impacts to responsible retailers; concern with limiting access to affordable celebration products without significant environmental benefit; strict safety standards already being followed by grocery partners; reminders customers about proper handling and disposal; participation in recent Creek cleanup efforts and lack of ballons or debris found; responsible practices that prevent environmental impacts; and she thanked the City in advance for implementing a ban on intentional release with no broader restrictions.

Mayor O'Brien reminded everyone that Council Member Vera was recused from the conversation about plastic bag bans.

Discussion ensued between staff and Council Members regarding feedback from the Sustainability Subcommittee; thoughtfulness in moving forward with the recommendations; support for the recommendations and checking in on an annual basis; education; the urgency of climate change; the need to meet climate goals; phasing in broader restrictions; the importance of policy to change behavior; state law; the local ordinance covering stores City-wide; support for a one year runway to allow businesses to adjust to the change; and previous efforts by the state to ban plastic bags.

Additional discussion ensued between staff and Council Members regarding differences between Option 1 prohibiting the sale and use of all plastic bags City-wide even if you already have them vs. Option 2 banning the sale and distribution of all plastic carryout bags from the point of sale; support for Option 2; the

Los Angeles city ban; the definition of reusable bags that includes the thicker plastic bags in Los Angeles but not in Culver City; the ban on single-use paper bags in Los Angeles that Culver City is not proposing; concern with pressure being put on the business community; a suggestion to allow a two year phase in; finding a cost-effective way to implement the program; a suggestion for the Chamber of Commerce to support alternative bag uses for bulk purchases; finding a way to educate clients and phase in alternative bag situations; and allowing for a one year phase in with a hardship waiver.

Vice Mayor Puza moved to support Option 2 with an 18-month phase in and a hardship waiver.

MOVED BY VICE MAYOR PUZA AND SECONDED BY COUNCIL MEMBER MCMORRIN THAT THE CITY COUNCIL: APPROVE OPTION TWO IN THE STAFF REPORT TO REGULATE SINGLE-USE BAGS NOT EXEMPTED BY CALIFORNIA PUBLIC RESOURCES CODE WITH AN 18 MONTH PHASE IN AND A HARDSHIP EXEMPTION.

Council Member Vera returned to the dais.

Discussion ensued between staff and Council Members regarding feedback from the Sustainability Subcommittee on the balloon ban in support for the recommendation made; appreciation for balloons; available alternatives; adding a clause to allow businesses in Culver City that are mostly balloon-focused to work with Economic Development to transition; support for a more aggressive approach with balloons due to severe environmental impacts; painful conversations from a business perspective; imposing guidelines that would send business outside of Culver enforcement; understanding the economic impact businesses; support for a ban on the release of balloons regardless of material or fill; education on how to be a better steward of the environment; feedback from Laguna Beach about their enforcement of their ban on balloons in public and lack of changes in the environment; small minority owned businesses; and acknowledgement of the issues caused by balloons.

Mayor O'Brien moved to adopt Options 3 and 4, with a phase-in for Option 4.

Additional discussion ensued between staff and Council Members regarding support for the thoughtful suggestions of the Sustainability Subcommittee; the feeling that no one would call the balloon police; the job as policy makers to push toward a solution; public comment indicating lack of balloon materials found during the recent Creek Cleanup; using education rather than enforcement; and the need to enforce things put on the books.

Council Member Vera seconded the motion.

Vice Mayor Puza proposed a substitute motion to support Options 2, 3, and 4 with the option for Economic Development to advise businesses with over 50% of their businesses dependent on balloons to begin a transition. Council Member Fish seconded the motion.

Additional discussion ensued between staff and Council Members regarding the feeling that the argument made regarding enforcement made no sense and would seem to indicate that there should be no environmental laws.

MOVED BY VICE MAYOR PUZA AND SECONDED BY COUNCIL MEMBER FISH THAT THE CITY COUNCIL: ADOPT OPTIONS TWO, THREE, AND FOUR IN THE STAFF REPORT WITH THE OPTION FOR ECONOMIC DEVELOPMENT TO ADVISE BUSINESSES WITH OVER 50% OF THEIR BUSINESSES DEPENDENT ON BALLOONS ON TO BEGIN A TRANSITION.

Council Member Vera indicated that he was able to participate in the discussion regarding plastic bottles as he had previously made the decision not to use plastic bottles in his place of business.

Additional discussion ensued between staff and Council Members support for the Sustainability Subcommittee recommendations; potential issues with a requirement for an additional fee; types of fees that are acceptable; looking at how to structure a potential fee; appreciation for the balancing conversation; business with health and the environmental impacts; previous environmental errors made; original recommendations made by the Sustainability

Subcommittee; efforts to balance competing elements; the end goal; eliminating trash and pollution in the Creek; health concerns with micro-plastics; expanding the ban to all singleuse plastic beverage bottles; plastic vs. aluminum; the experience of the city of Truckee; the additional fee to offset the cost of other climate initiatives in the City; support for exploration of a fee to allow the item to move forward; exploration of Option 2 and limiting bottles to under one gallon; bringing the item back to take things one step at a time; understanding requirements; ensuring requirements are not changed frequently to avoid confusion; hope for stronger regulations but openness to taking the first step with Options 4 and 5; clarification regarding support for a ban on all beverages in plastic beverages; insufficient support conducting an economic impact study; the feeling that the actions being taken are not supportive of businesses; support for incentives and education for businesses; costs to change out plastics for other materials; protective coatings used on aluminum and boxes; and allowing businesses to transition if they feel that they can.

Further discussion ensued between staff and Council Members regarding support for Option 4 as it does not take business away from local retailers; feasibility of the fee concept; bifurcating the motion; being mindful that all vendors for Fiesta La Ballona and any events are notified of the changes prior to committing; and ensuring that items being used are part of the approved list.

MOVED BY MAYOR O'BRIEN, SECONDED BY COUNCIL MEMBER VERA AND UNANIMOUSLY CARRIED, THAT THE CITY COUNCIL: SUPPORT OPTION FOUR FOR SINGLE-USE PLASTIC BEVERAGE BOTTLES.

Discussion ensued between staff and Council Members regarding the myth that one cannot be business-friendly and environmentally sustainable at the same time; education coupled with policy changes; seatbelts; the successful ban at City events and facilities; balancing the environment and people's health; Prohibition and the concern that a smoking ban would not work; municipalities that have gone smoke-free; number of states that had 100% smoke-free indoor laws as of 2024; major cities covered by comprehensive smoke-free laws; taking a gradual approach; community buy-in; support for Option 2; a suggestion to conduct an economic impact study; concern with hurting businesses; support for Option 2 with the smoking ban; creating specific smoking areas with proper receptacles to mitigate the liter; the prohibition on smoking in parks, city

facilities, multi-family homes, and outdoor dining; concern with going backwards by providing a smoking area; finding a middle-ground; the ability to enforce a prohibition on smoking within 50 feet of a business; concern with selective enforcement of a ban; de facto smoking zones for multi-family residential since people are not allowed to smoke in their units; looking at best practices and encouraging behaviors that support sustainability efforts rather than punishing people; supporting people where they are; offering education; and the goal to support the community in making better choices rather than criminalizing them.

Vice Mayor Puza moved to support Option 2 regarding smoking.

Further discussion ensued between staff and Council Members regarding non-enforceable feel-good changes; fines and penalties; education; the need for additional staff in Code Enforcement and Environmental Programs and Operations; and formulation of an enforcement proposal.

Council Member McMorrin seconded the motion.

Additional discussion ensued between staff and Council Members regarding further consideration by the Sustainability Subcommittee to provide information regarding proposed sites and enforcement strategies; a suggestion to amend the motion to look at whether adding more smoking prohibited sites is a more appropriate option; looking at appropriate options; best practices; getting closer to goals; looking at a ban on tobacco sales; a suggestion to have items come back for periodic review; and support for providing continued evaluation.

MOVED BY VICE MAYOR PUZA AND SECONDED BY COUNCIL MEMBER MCMORRIN THAT THE CITY COUNCIL: SUPPORT OPTION TWO REGARDING SMOKING WITH DIRECTION TO THE SUSTAINABILITY SUBCOMMITTEE TO EXAMINE THE ADDITION OF MORE SMOKING PROHIBITED SITES.

Discussion ensued between staff and Council Members regarding support for the recommendation of the Sustainability Subcommittee; issues related to astroturf; rapidly advancing technology; the feeling that astroturf may need more time for consideration by the Sustainability Subcommittee; ensuring a

focus on goals of the proposed changes; new use of artificial turf vs. removal of existing artificial turf; addressing what the consequences would be for someone putting in new artificial turf; complaint-based enforcement; required permits; existing restrictions on where artificial turf should be used; the inability to get a permit if artificial turf is banned; complaints received from the community; putting an emphasis on identification and enforcement; alternative products; rubber infill; mitigation of concerns with the heat island effect; a recent study by the California EPA; and agreement to remand the item back to the Sustainability Subcommittee for consideration with information about alternative sources of the product.

Council Member Fish requested City Council consensus to bring the item back annually to keep the conversation going with the business community and the community at large with revisions as needed.

Discussion ensued between staff and Council Members regarding the need for a study of economic impact of the changes; the 18month runway; consideration every two years; and support for pulling sales tax revenue information from the City side.

Consensus was received from Mayor O'Brien, Vice Mayor Puza and Council Members Fish and McMorrin to have a report back every two years with as much information as can be gleaned regarding the economic impact of proposed changes to the regulations and sales tax revenue from the products.

Council Member McMorrin signed off from the meeting.

CC - Introduction of an Ordinance Amending Chapter 9.01, Animals and Fowl, of the Culver City Municipal Code to Add a New Subchapter 9.01.800, et seq., Prohibiting the Sale and Use of Glue Traps

Wallis Nash, Senior Management Analyst, provided a summary of the material of record.

Mayor O'Brien invited public comment.

The following members of the public addressed the City Council:

Jackob Shaw thanked staff and the Sustainability Subcommittee for their work and consideration of the item; noted that glue traps were the single-most inhumane wildlife control device; discussed suffering due to the lack of a mechanism to instantly kill animals; a Canadian study indicating length of time animals suffer; the CDC (Centers for Disease Control) and California Department of Public Health warnings against usage due to increased risk for the hantavirus; and he thanked the City Council for their consideration.

Kristina Licare expressed appreciation for City Council consideration of the matter; discussed the need to advocate for the animals; immense suffering caused by the traps; the need to figure out other effective ways to address issues with animals coming into places where they are not wanted; and she expressed concern with letting children know that some animals are loved and celebrated while others are not deserving of compassion.

Chris Mudry echoed comments made by previous speakers; reported living in Culver City for five years; asserted that glue traps were a vicious horrible thing to do; discussed providing alternatives for addressing issues; the need to make changes in an economical way; setting an example for other cities to follow suit; and he felt the issue was an easy win.

Deborah Weinrauch asked the City Council to pass the ban; discussed trauma with seeing animals caught in glue traps; her experience trying to help a squirrel caught in a glue trap; she noted that glue traps were not environmentally friendly; and she asked the City Council to pass the ban.

Jeannine Wisnosky Stehlin was called to speak but was not present in person or online.

Discussion ensued between staff and Council Members regarding acknowledgement of the efforts of Culver City Congressman Ted Lieu to pass the federal Glue Trap Prohibition Act, and appreciation to Jakob Shaw for his leadership on the item and to PeTA (People for the Ethical Treatment of Animals) for all that they do on behalf of animals.
