Mayor Clarke invited public comment.

The following member of the audience addressed the City Council and the Parks, Recreation and Community Services Commission:

Lemar Betts, of The Skateside Skateboarding School, discussed The Skateside School and asked that money be put into the skate park for equipment and improvements.

Discussion ensued between staff and Council Members regarding special allocations for facilities; 10% of revenue collected for capital projects and improvements; the installation of restrooms at the Culver City Skate Park; and a suggestion to have Mr. Betts contact staff with concerns.

CC:PRCSC - (1) City Council and Parks, Recreation and Community Services Commission Consideration of Establishing the "Ballona Creek Connection Designated Dog Path," which would Augment the Existing Culver City Park Designated Dog Path by Incorporating it into a Continuous Dog Path that Connects the Ballona Creek Bike Path with the Baldwin Hills Scenic Overlook Gateway; and (2) [If Desired] City Council Adoption of a Resolution Designating such Dog Path and Rescinding Resolution No. 2014-R064

Patrick Reynolds, Parks Manager, presented plans for the proposed extension of the dog path.

Discussion ensued between staff, Council Members, Commissioners and David McNeill regarding keeping people on the dog path; utilizing the accessible portion of the trail; the Baldwin Hills Scenic Overlook; accessible components; dog path components; areas that allow dogs on leashes; areas that do not allow dogs at all; advocates; use of different segments; enforcement of the leash law; Code Enforcement; streamlining signage; effectiveness; clean up; regular maintenance; trash cans; width of the Nature Trail; concern with people being intimidated by larger dogs on the narrow trail; concern with the proposed route and proximity to areas heavily used by children and families; creating a special ADA route; support for having a dog path go through the park; park hours; the construction sequence; whether restrooms are sufficient for potential increased volume; proximity of the baseball fields and safety of dogs on the path; and restroom hours and accessibility.

Mayor Clarke invited public comment.

The following members of the audience addressed the Commission and City Council:

Ivan Bottlik discussed park operating hours; expressed concern with the amount of public outreach for the meeting; construction on Hetzler Road; issues with pedestrians in the roadway; signage; clarification that

there are currently no dogs allowed in the park; concern with adding dogs to an already difficult situation; lack of attention to signage; he questioned why a dog path would be created for a park that does not allow dogs; and he expressed opposition to the dog path connecting to the Baldwin Hills Scenic Overlook and the plan to extend the path to the Upper Fields.

Melinda Dickinson expressed concern with the limited hours of the upper restroom; she questioned why the dogs were being led to an area that they cannot enter; and she indicated that she did not like dogs going into the Overlook.

Discussion ensued between staff, David McNeill, Commissioners, and Council Members regarding the intention to allow dogs into Kenneth Hahn State Park; endorsement from the Commission and the City Council; timing of the item; creation of signage; and support for implementation of the dog path with the option for an alternative for non-handicapped users, interface with the Little League regarding the bathrooms, and specification of what kind of pooch bags would be available.

Additional discussion ensued between staff, David McNeill, Commissioners, and Council Members regarding sensitive habitat in the state park; ensuring that the path does not lead to an area where dogs are not allowed; communication with stakeholders; segregation and clearance of paths; the Audubon Society; people who do not read signage; enforcement in the state park; feedback from Hetzler Road residents; notification; the Park to Playa Walking Path; enforcement services; the signage program; and public outreach.

Vice Chair Stuart moved to adopt the staff recommendation with the suggested modifications.

Further discussion ensued between staff, Council Members and Commissioners regarding whether there is room to add a route behind Fields One, Two and Three from the Baldwin Hills Scenic Overlook Gateway; accessibility; creating an alternate route for dogs; and the location of the restrooms.

Commissioner Zeidman proposed an amendment to the motion to specify that an additional, non-compliant ADA path coming from the parking lot area to Field One be created to avoid the bleachers. Vice Chair Stuart accepted the amendment.

MOVED BY VICE CHAIR STUART, SECONDED BY CHAIR HEINEMAN AND UNANIMOUSLY CARRIED THAT THE PARKS, RECREATION AND COMMUNITY SERVICES COMMISSION RECOMMEND THAT THE CITY COUNCIL:

- 1. ESTABLISH THE "BALLONA CREEK CONNECTION ADA ACCESSIBLE DESIGNATED DOG PATH," WHICH WILL SERVE AS A LINK TO PROVIDE AN ADA ACCESSIBLE PATH FOR DOGS AND THEIR HANDLERS BETWEEN THE BALLONA CREEK BIKE PATH AND THE BALDWIN HILLS SCENIC OVERLOOK GATEWAY;
- 2. ADD A SECOND ALTERNATE PATH EXTENDING THE EXISTING CULVER CITY PARK DESIGNATED DOG PATH FROM THE LOWER BALL FIELD SOUTHEAST PARKING LOT UP TO THE BALDWIN HILLS SCENIC OVERLOOK GATEWAY THROUGH THE USE OF THE EXISTING ROAD AND THE TRAIL BEHIND THE FENCE THAT IS THE EASTERN BOUNDARY OF UPPER BALL FIELD #1; AND,
- 3. THAT STAFF COME BACK TO THE PARKS, RECREATION AND COMMUNITY SERVICES COMMISSION WITH ASSURANCES, FINISHED DRAWINGS AND THE FULL CONCEPT FOR FINAL APPROVAL.

Council Member Small moved to accept the recommendation of the Commission. Mayor Clarke seconded the motion.

Council Member Sahli-Wells requested assurances of adequate signage, trash receptacles, pooch bags, and a plan of enforcement.

Council Member Small and Mayor Clarke accepted the amendment.

MOVED BY COUNCIL MEMBER SMALL, SECONDED BY MAYOR CLARKE AND UNANIMOUSLY CARRIED THAT THE CITY COUNCIL:

1. ESTABLISH THE "BALLONA CREEK CONNECTION ADA ACCESSIBLE DESIGNATED DOG PATH," WHICH WILL SERVE AS A LINK TO PROVIDE AN ADA ACCESSIBLE PATH FOR DOGS AND THEIR HANDLERS BETWEEN THE BALLONA CREEK BIKE PATH AND THE BALDWIN HILLS SCENIC OVERLOOK GATEWAY;

- 2. ADD A SECOND ALTERNATE PATH EXTENDING THE EXISTING CULVER CITY PARK DESIGNATED DOG PATH FROM THE LOWER BALL FIELD SOUTHEAST PARKING LOT UP TO THE BALDWIN HILLS SCENIC OVERLOOK GATEWAY THROUGH THE USE OF THE EXISTING ROAD AND THE TRAIL BEHIND THE FENCE THAT IS THE EASTERN BOUNDARY OF UPPER BALL FIELD #1;
- 3. THAT STAFF COME BACK TO THE PARKS, RECREATION AND COMMUNITY SERVICES COMMISSION WITH ASSURANCES, FINISHED DRAWINGS AND THE FULL CONCEPT FOR FINAL APPROVAL BEFORE BRINGING THE RESOLUTION BACK BEFORE THE CITY COUNCIL; AND
- 4. THAT STAFF PROVIDE THE CITY COUNCIL WITH ASSURANCES THAT FOR BOTH THE "BALLONA CREEK CONNECTION ADA ACCESSIBLE DESIGNATED DOG PATH," AND THE EXTENSION OF THE EXISTING CULVER CITY PARK DESIGNATED DOG PARK THERE IS ADEQUATE SIGNAGE, A SUFFICIENT NUMBER OF TRASH RECEPTACLES, THE ONGOING AVAILABILITY OF DOG WASTE DISPOSAL BAGS AND A PLAN OF ENFORCEMENT OF APPLICABLE CULVER CITY MUNICIPAL CODE PROVISIONS REGARDING THE CARE AND HANDLING OF DOGS IN PUBLIC AREAS.

Discussion ensued between staff, Council Members and Commissioners regarding concern with the request to treat the Parks, Recreation and Community Services Commission equally in funding and attention with the Police and Fire Departments; the request to share a grant writer with other departments; percentage of General Fund spending for Parks, Recreation and Community Services; challenges of bringing in for profit programing; insurance requirements; youth sports comparisons with other area cities; the popularity of AYSO programs; allowing time and availability for all children to play in organized sports; demand; concern that there is a recreational disparity between those with money and those without; the Lacrosse program at the High School; the expense of travel basketball programs; the professionalization of youth sports; creating safe spaces for children; understanding the needs; missed opportunities; the changing population of the City; adult programming; making art and music available for people in the community to participate in;
