1                   **NOW, THEREFORE**, the City Council of the City of Culver City, California  
2 **DOES HEREBY ORDAIN** as follows:

3                   **SECTION 1.** Culver City Municipal Code Section 3.01.005 is hereby  
4 amended to read as follows:

5                   **§ 3.01.005 COMPENSATION FOR COUNCIL MEMBERS.**

6                   Pursuant to the City Charter and California Government Code Section  
7 36516, the salary of each Council Member is hereby established at One  
8 Thousand Two Hundred Sixty-One Dollars and Twenty-Six Cents  
9 (\$1,261.26) per month.

10                  **SECTION 2:** Notwithstanding, Section 4, below, the operative date of the  
11 salary increase set forth in this Ordinance shall be December 16, 2024.

12                  **SECTION 3:** Nothing in this Ordinance shall be construed to affect any suit  
13 or proceeding impending in any court, or any rights acquired, or liability incurred, or any  
14 cause or causes of action acquired or existing, under any act or Ordinance hereby  
15 repealed or amended as cited in this Ordinance; nor shall any just or legal right or  
16 remedy of any character be lost, impaired, or affected by this Ordinance.

17                  **SECTION 4:** Pursuant to Section 619 of the City Charter, this Ordinance  
18 shall take effect thirty (30) days after its adoption. Pursuant to Section 616 and 621 of  
19 the City Charter, prior to the expiration of fifteen (15) days after the adoption, the City  
20 Clerk shall cause this Ordinance, or a summary thereof, to be published in the Culver  
21 City News and shall post this Ordinance or a summary thereof in at least three (3) places  
22 within the City.

23                  **SECTION 5:** The City Council hereby declares that, if any provision,  
24 section, subsection, paragraph, sentence, phrase or word of this Ordinance is rendered  
25 or declared invalid or unconstitutional by any final action in a court of competent  
26 jurisdiction or by reason or any preemptive legislation, then the City Council would have  
27

1 independently adopted the remaining provisions, sections, subsections, paragraphs,  
2 sentences, phrases, or words of this Ordinance, and as such they shall remain in full  
3 force and effect.


