SUBJECT: Procurement Summary - Steel Fabricator Selection for Charles Gaines Commission

Dyson & Womack conducted a competitive bid process to identify and contract a qualified steel erection fabricator for the fabrication of a new public artwork by Charles Gaines, commissioned by the City of Culver City. This process was designed to meet rigorous standards required by government procurement policies and was structured to ensure compliance and the selection of the most qualified vendor.

Procurement Process Overview

Dyson & Womack issued a Request for Bids (RFB) to a pre-qualified list of steel fabrication firms with demonstrated experience in public art or architecturally complex fabrication projects.

Bidders were required to submit documentation verifying:

- California Contractors License in good standing;
- Department of Industrial Relations (DIR) registration and good standing;
- Commitment to paying union-scale wages for onsite labor; and
- Certifications such as California Small Business Enterprise (SBE) and Minority Business Enterprise (MBE), where applicable

Bids were reviewed based on cost, compliance, technical capacity, and demonstrated craftsmanship.

Bid Evaluation & Selection

Three bids were received and reviewed jointly by Dyson & Womack and Charles Gaines Studio.

Bid A (Lowest): Rejected due to concerns over fabrication quality and a lack of experience with complex sculptural works.

Bid B (Middle): Accepted. Met all procurement requirements, demonstrated high-quality fabrication capability, and offered a competitive cost. Firm holds:

- Active CA Contractor's License
- DIR Registration in good standing
- Certifications as a CA SBE and MBE
- Agreement to union wage standards for installation

Bid C (Highest): Rejected due to cost exceeding available budget with no proportional increase in quality or capabilities.
