3 Garacochea, Scott Wyant, Goran Eriksson, and Marcus G. Tiggs.

5 3. The number of votes given at each precinct and the number of votes
6 given in the City to each of the persons above named for the respective office for which the
7 persons were candidates are as listed in Exhibit "A" attached hereto and made a part
8 hereof.

9 4. Pursuant to Section 15360 of the Elections Code, the Elections Official,
10 under his direct supervision, caused to be completed a manual tally of two precincts, the
11 results of which are listed in Exhibit "B" attached hereto and made a part hereof.

12
13 5. The City Council declares and determines that Meghan Sahli-Wells,
14 Thomas Aujero Small, and Goran Eriksson are each elected as a Member of the City
15 Council for a full term of four years.

16 6. The Elections Official shall enter on the records of the City Council of
17 the City of Culver City a statement of the result of the election, showing: (1) the whole
18 number of ballots cast in the City; (2) the names of the persons voted for; (3) the office into
19 which each person was voted; (4) the number of votes given at each precinct to each
20 person; and (5) the total number of votes given to each person.

21
22 7. The Assistant City Manager/City Clerk shall immediately make and
23 deliver to each of the persons so elected a Certificate of Election signed by the Assistant
24 City Manager/City Clerk and authenticated. The Assistant City Manager/City Clerk shall
25 also administer to each person elected the Oath of Office prescribed in the Constitution of
26 the State of California and shall have them subscribe to it and file it in the Office of the City
27

1 Clerk. Each and all of the persons so elected shall then be inducted into the respective
2 office to which they have been elected.

3 8. The Assistant City Manager/City Clerk shall certify to the passage and
4 adoption of this resolution and enter it into the book of original resolutions.

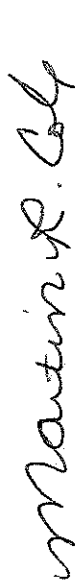
