CC - Presentation to the City Council of a Proposed Mural Project to be Installed at Stormwater Catch Basins Near Ballona Creek Bike Path Entrances

Kim Braun, Environmental Operations Manager, announced that City Hall had become a Zero Waste Facility as of April 22, 2019; she provided a presentation on celebrating Earth Day through Art; announced winners of the survey contest; discussed stormwater outreach; MS4 permit requirements; educational mural projects; enhancing the bike path and entrances around Ballona Creek; the Ballona Creek Revitalization Plan; proposed mural locations; and samples for City Council consideration.

Council Member Lee suggested working with green groups in the School District.

Earle Hartling provided background on himself; reported that a tentative agreement had been reached for contract negotiations with the Sanitation District; he urged the Mayor to attend the Collective Committee meeting and vote to ratify the contract; and he indicated that support of the agreement would not adversely impact district finances.

Jim Shanman invited everyone to attend activities for Bike Month in May.

Seth Horowitz discussed changes taking place in Culver City; his daughter's participation in the Interscholastic Equestrian League; and noted that the Overall Varsity Champion represented Culver City High School.

Mark Lipman provided a draft letter to the City Council to be sent to the County Supervisors on the vacancy survey from the US Census Bureau; announced a partnership with Culver Arts and the Wende Museum to present the first small press book festival in Culver City; and he discussed City sponsorship.

Discussion ensued between Council Members regarding the sponsorship, and encouragement to Mr. Lipman to contact Susan LaTempa as a potential resource.

Khin Khin Gyi, Culver City Democratic Club, expressed appreciation for the acknowledgement of Autism Awareness Month and Earth Day; discussed incidents at the Inglewood Oil Field and failure of the alarm systems to alert the operator; and she asked the City Council and the Supervisors for the

City of Los Angeles to suspend the permits for all operations of the Inglewood Oil Field until issues can be addressed.

Mayor Small introduced the item; explained procedures for the transition; he thanked Joanna Brody, his colleagues, the Sister City Committee, the Mayme Clayton Museum, staff, and everyone who supported him over his past year as Mayor; and he discussed awards accepted for the City during the past week.

Mayor Small invited public input.

The following members of the audience addressed the City Council:

Kelly Kent extended gratitude to Mayor Small for his service; thanked him on behalf of the Board of Education for his support of the Superintendent and the District; expressed appreciation for what he brought to the community; acknowledged how much he gave to the job; and she thanked staff for supporting him.

Paula Amezola thanked Mayor Small for his leadership; discussed equity, inclusivity and diversity; inclusive growth; housing for every economic level; protecting diversity in the community; and recent achievements.

Council Member Fisch nominated Vice Mayor Sahli-Wells to serve as Mayor of Culver City for a 12-month term.

Council Member Eriksson discussed the divisive mayoral rotation one year ago; the value of mayoral rotation policy to allow for predictability and transparency; development of a policy based on learned experiences; allowing Council Members to prepare for their upcoming role; the Brown Act; the painful conflict created in the City last year; the 2010-2017 mayoral rotation policy; fairness and equity; consistency with earlier statements; support for the Vice

Mayor in order to bring unity to the City; and doing the right thing for the City in the long term.

MOVED BY COUNCIL MEMBER FISCH, SECONDED BY COUNCIL MEMBER LEE AND UNANIMOUSLY CARRIED, THAT THE CITY COUNCIL: ELECT VICE MAYOR SAHLI-WELLS AS MAYOR FOR A 12-MONTH TERM.

Council Member Small nominated Council Member Eriksson to serve as Vice Mayor.

MOVED BY COUNCIL MEMBER SMALL, SECONDED BY COUNCIL MEMBER LEE AND UNANIMOUSLY CARRIED, THAT THE CITY COUNCIL: ELECT COUNCIL MEMBER ERIKSSON AS VICE MAYOR FOR A 12-MONTH TERM.

The new Mayor and Vice Mayor received their pins.

Council Member Lee noted the need for strong leadership in the next year and discussed benefits to the City in the long run.

Vice Mayor Eriksson was looking forward to working with Mayor Sahli-Wells and expressed appreciation for the support of his colleagues.

Mayor Sahli-Wells congratulated Vice Mayor Eriksson.

Council Member Small congratulated Mayor Sahli-Wells and Vice Mayor Eriksson.

Council Member Fisch thanked Council Member Small for his leadership and discussed exciting challenges in the coming year.

Mayor Sahli-Wells thanked everyone for their support and Council Member Small for his outstanding year as Mayor; discussed work to be done; challenges ahead; shared prosperity; economic development strategies; supporting community; development of a community benefits package; climate action; land use authority; she proposed forming a Mayor's Youth Council; she wanted to see childcare provided for public meetings; she thanked her family for their support; thanked her high school government teacher for being present to support her and for his inspiration; and she invited everyone to attend the reception at the Culver Hotel.

BOARD, HOUSING AUTHORITY BOARD, PARKING AUTHORITY BOARD, AND SUCCESSOR AGENCY BOARD: ADOPT RESPECTIVE MOTIONS CONFIRMING THAT THE MAYOR AND VICE MAYOR SHALL SERVE AS CHAIR AND VICE CHAIR OF THESE BODIES, RESPECTIVELY, EACH FOR A 12-MONTH TERM.
