

## **RESOLUTION NO. 2021-R**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CULVER CITY, CALIFORNIA, AMENDING THE REGULAR MEETING DATES OF THE CITY COUNCIL FOR CALENDAR YEAR 2021, AND RESCINDING RESOLUTION NO. 2020-R114.

WHEREAS, at the City Council meeting of November 9, 2020, Resolution No. 2020-R114 was adopted setting the regular meetings for calendar year 2021; and

WHEREAS, the City Council desires to make changes to the 2021 regular meeting calendar.

NOW, THEREFORE, the City Council of the City of Culver City, California,  
DOES HEREBY RESOLVE as follows:

1. Consistent with Charter Section 608 and CCMC Section 3.01.100, the dates listed in Exhibit A, attached hereto and made a part hereof, are hereby set as the City Council's regular meeting dates for calendar year 2021.

2. The dates of the regular meetings listed in Exhibit A may only be changed by the City Council's adoption of a resolution at a regular City Council meeting.
