3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 CULVER CITY, CALIFORNIA, AMENDING THE START TIME
5 FOR THE REMAINING REGULAR MEETING DATES OF THE
6 CITY COUNCIL FOR CALENDAR YEAR 2026, AND
7 RESCINDING RESOLUTION NO. 2025-R090.

10 WHEREAS, Culver City Municipal Code (CCMC), Section 3.01.100, states

12 Hall on the second and fourth Mondays of each month at 7:00 p.m., unless otherwise
13 specified by resolution of the City Council; and

14 WHEREAS, at the City Council meeting of November 10, 2025, Resolution
15 No. 2025-R090 was adopted setting the regular meetings for calendar year 2026; and

16 WHEREAS, the City Council desires to amend the regular meeting dates for
17 calendar year 2026.

18 NOW, THEREFORE, the City Council of the City of Culver City, California,
19 DOES HEREBY RESOLVE as follows:

20 1. Consistent with Charter Section 608 and CCMC Section 3.01.100, the
21 dates and times listed in Exhibit A, attached hereto and made a part hereof, are hereby set
22 as the City Council's regular meeting dates for calendar year 2026.

23 2. The dates and times of the regular meetings listed in Exhibit A may
24 only be changed by the City Council's adoption of a resolution at a regular City Council
25 meeting.

4. This Resolution shall take effect immediately upon its adoption.
