Item PH-1
(Out of Sequence)

Site Plan Review, SPR P-2014186 and Density and Other Bonus Incentives, DOBI P-2014, for proposed 3-story building consisting of 36 multi-family units which will include 3 very low income affordable units above as an 85 space subterranean parking level and Administrative Use Permit P-2014185 for Tandem Parking at 4025 Grand View Boulevard

Jose Mendivil, Associate Planner, provided a summary of the material of record.

Sol Blumenfeld, Community Development Director, discussed the feasibility study submitted by the applicant; the affordability gap; the physical requirement threshold; concessions; accommodating the development program; meeting the density threshold; obligations of the City; providing concessions if findings are made in support of the physical requirement; the financial feasibility aspect; the convoluted nature of the law; conformance requirements; he indicated that an affordable housing item would be going before the City Council in February; he discussed the lack of affordable housing projects in the City; and encouragement to implement more affordable housing by the City Council.

Jose Mendivil, Associate Planner, noted several objectives in the resolution from the Housing Element and the General Plan to encourage support for affordable housing.

Chair Lachoff invited public comment.

The following members of the audience addressed the Commission:

Jeff Smith, developer, provided background on himself and introduced his team.

Tony Pleskow, architect, discussed his experiences with former Commissioner Smith Frost and he provided a presentation on the project.

Ava Schwartz expressed concern with the omission of the Culver West Skilled Nursing Facility in the report; she discussed the changed business model for the facility; increased traffic in the area; noise pollution; and light pollution.

Rich Kissell expressed support for the project; noted the benefits to having three bedroom units; discussed affordable housing stock; and reduced travel times.

Steven Rose, Chamber of Commerce, reported Chamber support for the project; discussed housing shortages on the Westside for the number of jobs; short term leases; small variances requested; benefits to the City for the number of units created; and diversifying housing stock in the City.

Chair Lachoff, Vice Chair VonCannon and Commissioner Wyant indicated that while they are members of the Chamber of Commerce, they did not participate in the decision to support the item.

Discussion ensued between the applicant, staff and Commissioners regarding fire access into the project; the preliminary plan review process; the likelihood that there would be many children living in the development; bicycle parking; area schools; appreciation for the affordable housing provided; concern with a backup on Grandview for those trying to enter the parking lot; the onsite manager; support for the project and design; the challenging nature of the space; the distance between units; use of the seven-foot addition; increased step backs on the third floor; and increased affordable housing stock in the City.

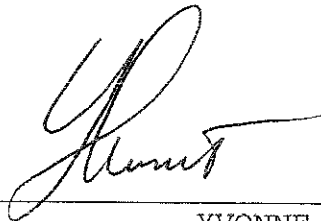

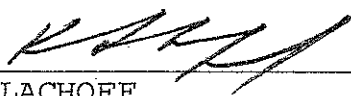
