Discussion ensued between staff and Committee Members regarding a suggestion for the theme to be Mentoring the Dream; alignment with the King Center; centering everything around the theme including the volunteer opportunity; current significance of the Voting Rights Act; background and significance of the King Center; a suggestion for a theme of Seeking Peace, Pursuing Justice, Spreading Compassion; the

possible student exhibit; the student prompt; concern with the proposed dream theme; reality vs. the dream; moving forward with the item vs. tabling it to the next meeting; the feeling that themes are not typically put on save the date notices; allowing ad hoc subcommittees and marketing to move forward; ensuring that items are approved by the Committee; concern with delaying planning; the feeling that having a theme will allow subcommittees to move forward; a suggestion for the theme to be Diversity Unites Us, Love Leads Us, Action Propels Us; and the theme used for 2025.

Additional discussion ensued between staff and Committee regarding support for the dream theme; proclamation; education; the prompt; concern that the dream has lost its meaning; adding a more specific subtitle; progress made that has been lost; development of the theme by the King Center; moving along the mission of MLK; alignment on a theme; interpreting 2025's evolution of the dream; focusing on trying to make the dream a reality; the importance of being united; having tangible things for the volunteer opportunity and for the students to write about; support for the theme of Diversity Unites Us, Love Leads Us and Action Propels Us; the need to progress beyond the dream; the need to work together; agreeing to disagree; respecting differences; combining the themes into Diversity Unites Us: Activating the Dream through Peace, Justice, and Compassion; and a reminder that the official motto of the United States in Latin translates to: Out of Many Come One.

Additional discussion ensued between staff and Committee Members regarding the Student Engagement Ad Hoc Subcommittee; Brown Act issues; finding other ways to have students involved in the event; an instance where a subcommittee created an email chain and then consulted a different subcommittee so there were five people on the email in violation of the Brown Act; student outreach; the student engagement task; confusion; being clear that the Student Engagement Ad Hoc Subcommittee does everything

related to students except for entertainment; delayed response; expansion of the initial role of the Student Engagement Ad Hoc Subcommittee to contact the School District; increasing participation; clarification on what people are engaging in; considering anything on the stage to be entertainment; supporting service hours; the point of contact; formation of a Volunteer Service Project Ad Hoc Subcommittee; potential coordination of students; the inability to mix duties of subcommittees; the task of the Student Engagement Ad Hoc Subcommittee in practice that caused a violation of the Brown Act; passing along information between subcommittees; the particular purpose of the Student Engagement Ad Hoc Subcommittee; a recommendation to dissolve the ad hoc subcommittee if there is confusion as to the proposed task; and reinterpretation of the charge of the ad hoc subcommittee.

Further discussion ensued between staff and Committee Members regarding support for increased student engagement; report outs to the full Committee; bringing items that are out of the purview of the Student Engagement Ad Hoc Subcommittee to the full Committee to be taken up by another ad hoc subcommittee; the charge to act as a liaison between the School District and the full Committee; members who sit on multiple subcommittees; daisy chain communication that violates the Brown Act; encouragement for Committee Members to wait until full Committee meetings to discuss their subcommittee work; the Run of Show conversation; cross contamination of subcommittees; and being clear with the charge of different subcommittees.

Chair Bibbins-McKeever reported that the Public Relations, Marketing and Entertainment Ad Hoc Subcommittee had met with staff to determine next steps, and she questioned whether the call for entertainers had gone out and whether any submissions were received.

Discussion ensued between staff and Committee Members regarding clarification that the item would be sent to subcommittee members for final review before it goes out; review of submissions once received for recommendation to the full Committee; the media list; calendar listings for Black events in the area; posting event information; outreach to other organizations and schools; performances by student ensembles; providing something relevant to younger audiences that still connects to MLK Day; interest in participation from the Middle School Choir Director; potential scenarios for participation; involvement of High School participation of a gospel singer; ensuring that vetting a singer is built into the timeline; building in rehearsal time; the teacher involved; students who regularly perform; integration of the choir with the students from Bloom Arts; matching the level of professionalism and amount of production; song selection; and blending of groups.

Member Raynor discussed the work of the History and Culture for Juneteenth and MLK Ad Hoc Subcommittee; the importance of the Voting Rights Act; using the lobby to display the history; actions of the Supreme Court; student involvement; and having an education focus for the event.

Discussion ensued between staff and Committee Members regarding a big moment in American History when President Johnson spoke to Congress using the phrase "We shall overcome"; ideals for the country; highlighting different milestones in the history of voting rights; social events and legislation; the importance of allies; recurring themes of the white savior; the need for people in power to help; clarification that there are no subcommittee recommendations yet; a suggestion to have students dress up and mimic famous historic figures; creating engagement; ensuring proper execution; and setting up things to represent what people went through before the Voting Rights Act.

Additional discussion ensued between staff and Committee Members regarding use of the Rotunda Room, the lobby, and outside space; putting entertainment outside if weather permits; being flexible; feedback from the previous year that the space was dark and there was no engagement from the audience; conversation within the ad hoc subcommittee; and staff agreement to reserve the field.

Further discussion ensued between staff and Committee Members regarding clarification that the Sponsorship Donation Ad Hoc Subcommittee had not met; the 2028 Summer Olympics Preparation Ad Hoc Subcommittee had not met; and no information was available as to when the City Council Olympic Committee would be meeting.

Discussion ensued between staff and Committee Members regarding the Student Engagement Ad Hoc Subcommittee; possible activities that are not on the stage; contact with teachers to explore having an exhibit with student creative expressions; connections to organizations that focus on student artists; agreement to email information to staff; providing the date to the School District to be added to the master calendar of local events; outreach to elected officials; timing of the winter break for the schools; outreach by the PR and Marketing Ad Hoc
