Consideration of Amending Tract Map No. 73978-A for the Ivy Station mixed use development located at 8809 Washington Boulevard (Project)

Jose Mendivil, Associate Planner, presented the proposed amending map for the subdivision governing the mixed-use project known as Ivy Station; discussed the project description; the existing mixed-use development; the existing subdivision; the requested modifications; airspace lots; corrections needed due to subsequent determination that certain airspace lots inadvertently crossed property lines on underlying ground lots owned by different parties; Ivy Station seeks to correct map errors by amending the City of Los Angeles Tract Map No. 73977 and City of Culver City Tract Map No. 73978 by creating additional airspace lots; the amending map is required to address corrections; the process; technical corrections that do not change operations or physical characteristics; and the staff recommendation.

MOVED BY COMMISSIONER JONES, SECONDED BY VICE CHAIR MENTHE AND UNANIMOUSLY CARRIED, THAT THE PLANNING COMMISSION OPEN THE PUBLIC HEARING.

Kyndra Casper, DLA Piper, spoke representing the applicant, discussed the proposed tract map modification; creation of physical air lots that sit in the Metro right of way; clarification that no physical changes or changes to the development are proposed; she presented photographs of the area; discussed the jurisdictional map; approval of the project in 2016 by the City Council; current conditions; she presented examples of proposed changes to the map and the existing project; and noted the intent to create air space lots over Metro right of way which they hold easements on.

Chair Reilman invited public comment.

Ruth Martin del Campo, Current Planning Secretary, reported no requests to speak.

Responding to inquiry, Mark Fox, Iacobellis & Associates, discussed the genesis of the item; conveyance; review of the title survey; the remedy proposed by the title company to carve out additional air lots occurring over the MTA property only; he clarified that the action would not allow them to do anything that they had not originally intended on doing; discussed providing the capability of having an airspace lot that can be conveyed; and separating out the title.

MOVED BY COMMISSIONER JONES, SECONDED BY VICE CHAIR MENTHE AND UNANIMOUSLY CARRIED, THAT THE PLANNING COMMISSION CLOSE THE PUBLIC HEARING.

Discussion ensued between Ms. Casper, staff, and Commissioners regarding concern with opening up Metro to future fees from the applicant; clarification that Metro wanted the change; airspace lots that crossed ground lots; clarification that Metro is part owner of the land; cleaning up lots that were crossing; and clarification that Metro signed off on the process to move forward.

MOVED BY COMMISSIONER JONES, SECONDED BY VICE CHAIR MENTHE AND UNANIMOUSLY CARRIED, THAT THE PLANNING COMMISSION: RECOMMEND THE CITY COUNCIL APPROVE, ON CONSENT, AMENDING MAP P2024-0224-TTM/MOD (TRACT NO. 73978-A), AS STATED IN PROPOSED RESOLUTION NO. 2024-P014.
