

Chair Guzzetta called the regular meeting of the Fiesta La Ballona Committee to order at 7:07 P.M. via Webex.

### **Public Comment for Items NOT On the Agenda**

The following member of the public addressed the Committee:

Margot Bennett, Women Against Gun Violence, provided background on herself; requested that the National Rifle Association (NRA) not be allowed to have a booth at the Fiesta; she cited failure of the NRA to staff their booth properly in previous years; she felt that NRA was not enhancing the event

with community engagement; and she received clarification that guidelines would be coming forward in the future.

James Klein submitted a comment that expressed support for banning the NRA booth at Fiesta La Ballona; discussed feedback from attendees offended by the NRA booth; Fiesta La Ballona as reflecting the values of the City and concern that people would infer that Culver City supports the NRA; lack of staff at the NRA booth; other groups that could use the booth space; and concern with advocating for loosening gun laws that leads to increased gun violence in the community and the nation.

Nancy Barba provided background on herself; thanked the Committee for their work on Fiesta La Ballona; echoed previous comments about the NRA booth noting that it seemed out of place in a community family-focused event; felt that organizations that do not bother to show up for the event should not be allowed to take up the important real estate; and she asked that the NRA not be invited back.

Stacey Wiren submitted a comment in support of Karim Sahli's statements regarding the NRA; noted that the NRA had not complied with the terms of the agreement and therefore forfeited their right to participate in the future; she saw no place for an organization that promotes the use of firearms in a community with so many schools; and stated that they would be relieved never to see the booth there again.

**FLBC - (1) Create Fiesta La Ballona Committee Work Plans; (2) Draft A Written Report to the City Council Regarding the Work Plans; and (3) Authorize Transmittal of the Report to the City Council**

Patricia Mooney, Senior Management Analyst, provided a summary of the material of record.

Discussion ensued between staff and Committee Members regarding reporting back on work plans to document whether or not items have been completed; ensuring that feasible items that can be completed in the one year time frame are included in the work plan; and the process.

The Committee agreed upon including the following 2021 accomplishments in the work plan:

- Assisted City staff in coordinating a successful Fall-themed Festival during a pandemic; and,
- Sponsorship Ad Hoc Subcommittee worked with City staff to receive generous donations including one of the largest ever from Amazon Studios with sponsorship totals equivalent to \$59,650.00; and,
- Entertainment Ad Hoc Subcommittee worked with City staff to have a very successful line-up of Professional and Community performers; and,
- Marketing Ad Hoc Subcommittee worked with City staff to request community feedback for the name of the Fall-themed 2021 Fiesta La Ballona event, with the name chosen as "Fiesta La Boo-llona - From the Heart of Screamland"; and,
- Special Activities Ad Hoc Subcommittee worked with City staff to produce the first ever Contest Corner for the public to participate in a variety of contests along with Fall-themed activities.

Additional discussion ensued between staff and Committee Members regarding analyzing data collected for 2021 to further review, revise, and improve vendor selection; evaluating and recommending new vendor pricing in all categories; analyzing data on the 2021 survey; preferred vendors; community engagement to determine future objectives of Fiesta including date and themes; allowing for flexibility; and enforcement.

The Committee agreed upon including the following tasks for the Fiesta La Ballona Committee 2022 Work Plans

1. Develop and implement the selection procedure for Fiesta La Ballona's Beer and Wine Garden; and,
2. Review and recommend new pricing in all Fiesta La Ballona categories; and,
3. Review and revise the process for Fiesta La Ballona vendor selection and enforcement of the terms of the agreement; and,
4. Better engagement of the community in the process of planning the Fiesta La Ballona.

MOVED BY MEMBER SWENSON, SECONDED BY MEMBER MEJIA AND UNANIMOUSLY CARRIED (ABSENT MEMBERS MARTIN-STRAW AND WAYNE), THAT THE FIESTA LA BALLONA COMMITTEE:

(1) CREATE FIESTA LA BALLONA COMMITTEE WORK PLANS AS DISCUSSED; AND,

(2) DRAFT A WRITTEN REPORT TO THE CITY COUNCIL REGARDING THE WORK PLANS; AND,

(3) AUTHORIZE TRANSMITTAL OF THE REPORT TO THE CITY COUNCIL.

**Public Comment - Items Not On the Agenda (Continued)**

Chair Guzzetta invited public comment.

The following members of the public addressed the Committee:

Karim Sahli expressed appreciation for the work of the Committee; expressed hope that the NRA booth would never again be allowed to be part of the family-centric festival; discussed historical lack of participation by the NRA in staffing the booth at the festival; and lack of abidance to the terms of the agreement for the past several years.

Dr. Kelly Kent provided background on herself; asked that the Committee not allow the NRA to have a booth at the Fiesta in the future; expressed support for using breach of the agreement as a way out of the toxic relationship; felt that neutrality was a false premise and served the violent status quo; discussed recent shooting scares experienced by the School District; bans on inappropriate sexual content; and she reiterated her request that the NRA be banned from the event.

Patricia Mooney, Senior Management Analyst, read comments submitted by Bonnie Seeberger expressing appreciation to the Committee for their work on the Fiesta, and echoing previous comments that the NRA be disallowed to have a booth due to their lack of meaningful participation and the harmful nature of their cause which jeopardizes the health safety and welfare of the community and the nation.



Chair Guzzetta expressed appreciation for the public comment; discussed First Amendment issues; and curating the desired type of event and environment.
