

RESOLUTION NO. 2016-R

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CULVER CITY, CALIFORNIA AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH THE LOS ANGELES COUNTY DEPARTMENT OF COMMUNITY & SENIOR SERVICES, AND THE ACCEPTANCE OF GRANT FUNDS, FOR THE ELDERLY NUTRITION PROGRAM GRANT FOR FISCAL YEAR 2016-2017 THROUGH FISCAL YEAR 2019-2020.

WHEREAS, pursuant to the Older Americans Act (42 United States Code Section 3001 et seq.), Title III (Grants for State and Community Programs on Aging), Parts B and C (Grants for Supportive Services and Senior Centers, and Nutrition Services, respectively), the Los Angeles County Department of Community & Senior Services has received funding to establish, implement and oversee program services for its Elderly Nutrition Program; and

WHEREAS, the City of Culver City has been awarded grant funds through the County's Elderly Nutrition Program Grant in order to fund and administer the Culver City Senior Nutrition Program in Fiscal Years 2016/2017 through 2019/2020; and

WHEREAS, in order to receive the grant funds, the City Council must designate and authorize a representative to sign the Grant Agreement on behalf of the City.

NOW, THEREFORE, the City Council of the City of Culver City, California, DOES HEREBY RESOLVE as follows:

1. The City Council hereby authorizes the acceptance of Elderly Nutrition Program Grant Funds awarded by the Los Angeles County Department of Community & Senior Services in an amount determined by the Los Angeles County Department of Community & Senior Services, to fund the Culver City Senior Nutrition Program in Fiscal Years 2016/2017 through 2019-2020.

2. The City Council hereby approves the Grant Agreement between the City and the Los Angeles County Department of Community & Senior Services for the four year cycle commencing on July 1, 2016 and ending June 30, 2020.

3. The City Council hereby authorizes the following persons to execute, on behalf of the City, the Grant Agreement and all documents related thereto, and administer and manage the Grant, for Fiscal Years 2016/2017 through 2019/2020: John Nachbar, City Manager; Daniel Hernandez, Parks, Recreation and Community Services Director; and Armando Abrego, Senior and Social Services Manager.
