1) Updates and Discussion Relating to the Creative Economy Report of Culver City; and 2) (As Desired) Appoint a Second Commissioner to the CAC Ad Hoc Creative Economy Report Subcommittee

Christine Byers, Cultural Affairs Coordinator, noted that Chair Dickter would be up for reappointment to the Commission in June.

Chair Dickter reported that Vice Chair Cherry and Commissioner Williams would be stepping down as Commissioners; discussed the Creative Economy Report and thanked staff for their efforts; reported that Otis would be unveiling the County of Los Angeles Creative Economy Report on May 18; discussed partnerships with the County; pointed out that Culver City is the first small City to work with the LAEDC to create such a report and to develop policy, programming and promotional recommendations from the report; and he reported positive response from outreach.

Susan Obrow, Special Events Coordinator, reported that Laura Zucker of the Los Angeles County Arts Commission had been complimentary and would post the Culver City Creative Economy report to share with the wider community; indicated that she had facilitated communication between Chair Dickter and the Executive Director for the City of Los Angeles Cultural Affairs Department; and she reported attending the Los Angeles Arts Funders meeting noting that the link to the Culver City Creative Economy Report had been shared with them.

Chair Dickter discussed promotion of the report; Los Angeles County engagement of their constituencies and the public; adapting Los Angeles County methods for use in Culver City; the Creative Economy Report Subcommittee; the request from Council Member Sahli-Wells to hold a launch for the project; he noted that the Commission is in flux and would have new members in July; and he discussed the need to fill the vacancy on the Creative Economy Subcommittee left by Vice Chair Cherry.

Commissioner Pali volunteered to take Vice Chair Cherry's place on the Creative Economy Report Subcommittee.

Chair Dickter discussed the work of the Creative Economy Report Subcommittee; encouraged maintaining a collaborative, deliberative process, using the expertise that everyone brings to the Committee; and he noted that Commissioner Pali, brings his knowledge of the arts and business to the process.
