Item A-1

Update and Discussion of Affordable Student Housing on Campus, Development at 10100 Jefferson, and Hudson Pacific's Community Engagement Plan

James Limbaugh, Ph.D., President, WLAC, provided an update on the development at 10100 Jefferson for affordable student housing on campus; discussed Measure LA; type of housing provided; rental pricing; timing; requirements; other potential locations for the affordable housing project in the county; the annual fireworks display; the community newsletter; impacts to the neighbors; the significant period of demolition and construction over the next five years; changing the culture of the campus with a residence hall; and the feeling that the benefits outweigh the disadvantages.

Discussion ensued between staff and Committee Members regarding percentage of students that come from families that exist below the poverty line; the selection process; those who are housing and/or food insecure; students who are parents; transportation; connectivity; research indicating that students that live on campus are more engaged and more likely to stay in school; a letter of support from the City Council; future communication

with the Transportation Department if WLAC is selected; and agreement that WLAC will make a report on the project at a City Council meeting.

James Limbaugh, Ph.D., President, WLAC, read a statement regarding the development at 10100 Jefferson and noted that everything was moving forward despite delays due to the pandemic.

Michelle Long-Coffee, Public Relations Director WLAC, discussed the community engagement plan.

Discussion ensued between staff and Committee Members regarding issues encountered with active oil wells and clarification that 10100 Jefferson is both in the City of Los Angeles and in Culver City.

Item A-2

Discussion Regarding the 2028 Olympics and Collaborative Partnership with West Los Angeles College Associated with the Utilization of Facilities

Jesse Mayes, Assistant City Manager for Culver City, introduced the item.

Discussion ensued between staff and Committee Members regarding money for upgrading athletic facilities and fields included in Measure LA; collaboration between the City and WLAC to upgrade existing facilities; use of WLAC in 1984; utilization of sports facilities for training; ensuring that students are able to maintain their regular schedule; utilization of performance venues; indoor and outdoor capacity; use of soundstages when complete; use of media facilities; unused facilities; ensuring that the theater is state of the art; creating an events center; the new library; meeting the various needs for different sized venues; adaptive reuse; serving the community; remodeling the buildings within a particular set of guidelines; community rentals; studio rentals; parking rentals; the inventory of available spaces in the City; research into determining whether fields are used to the fullest capacity; potential Olympic usage; lack of lighting for the fields; neighbor concerns; the conference center; views from WLAC; a suggestion for a café or commercial food venue; public use of the campus on Saturdays; library access; making WLAC a community destination; and changes over the next five years.

Discussion of Workforce Development Opportunities

Elaine Gerety Warner, Economic Development Director for Culver City, discussed collaboration between the City and WLAC; dedicated programs; internships; shadowing; speaker series; and developing existing talent and integration into the community.

Discussion ensued between staff and Committee Members regarding apprenticeships; climate change-based apprentices; the majority of green jobs in California as located in Los Angeles county; workforce money from the state to WLAC; making workforce opportunities part of a credit bearing class; on-the-job training; work opportunities through the City; development of a partnership so that both parties benefit; structuring a pilot program; community outreach; creation of a Mobile Climate Change Education Center; and prioritizing to keep the message going.
