3	AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CULVER CITY, CALIFORNIA, ADOPTING VERY HIGH,
4	HIGH, AND MODERATE FIRE HAZARD SEVERITY ZONES BY AMENDING AND RESTATING IN ITS
5	ENTIRETY SECTION 9.02.400 OF THE CULVER CITY MUNICIPAL CODE REGARDING THE DESIGNATION OF
6	VERY HIGH, HIGH, AND MODERATE FIRE HAZARD SEVERITY ZONES.

8 9	WHEREAS, pursuant to California Government Code Section 51178, the
10	State Fire Marshal is required to identify areas in the State as Moderate, High, and Very
11	High Fire Hazard Severity Zones (FHSZ) based on consistent statewide criteria and the
12	severity of fire hazard that is expected to prevail in those areas; and
13	WHEREAS, the State FHSZ maps are being updated to more accurately
14	reflect zones in California that are susceptible to wildfire through the incorporation of new
15	science in local climate data and improved fire assessment modeling in determining hazard
16 17	ratings; and
18	WHEREAS, on March 24, 2025, the Office of the State Fire Marshal (OSFM)
19	issued the 2025 Recommended Local Responsibility Area (LRA) FHSZ map for Culver City
20	- Los Angeles County, identifying certain Very High, High, and Moderate Fire Hazard
21	Severity Zones in the City's LRA; and
22	WHEREAS, pursuant to California Government Code Section 51178.5, the
23	
24	City of Culver City ("City") made the draft updated FHSZ map recommendations available
25	for public review and comment within 30 days of receiving them; and

WHEREAS, pursuant to California Government Code Section 51179(a), the City must designate, by ordinance, moderate, high, and very high FHSZs in its jurisdiction within 120 days of receiving recommendations from the State Fire Marshal; and

WHEREAS, pursuant to California Government Code Section 51179(b)(3), the City is prohibited from decreasing the level of fire hazard severity zones identified by the State Fire Marshal for any area within the City, for example by reducing areas designated as very high FHSZs by the State Fire Marshal to moderate or high fire hazard severity zones; however, pursuant to California Government Code Section 51179(b)(1), the City may increase the recommended levels of FHSZs following a finding supported by substantial evidence in the record that the requirements of California Government Code Section 51182 are necessary for effective fire protection within the area; and

WHEREAS, the Culver City Fire Department (CCFD) is recommending increasing the State-recommended FHSZ designation for the Wrightcrest neighborhood, as well as for the lower Culver Crest neighborhood, which are currently already within Very High FHSZs; as such, property owners in those areas will not have new requirements; and

WHEREAS, during Santa Ana wind events, when the hot, dry air is blowing in off the deserts, fueling potential wildfire starts, the aforementioned neighborhoods are among the most vulnerable within the City's jurisdiction; thus, by continuing to attach the Very High designation to these areas, it will allow CCFD to better manage the City's brush clearance and help CCFD enforce 100 feet of defensible space around structures; and

WHEREAS, the City Council desires to adopt the CCFD's recommended
FHSZ designations, which increase certain State-recommended FHSZs and adopt other
State-recommended FHSZs, by amending and restating in its entirety Section 9.02.400 of

the Culver City Municipal Code (CCMC), which was previously adopted by the City in 2012 1 when only Very High FHSZs were required to be approved by ordinance. 2 NOW, THEREFORE, the City Council of the City of Culver City, California, 3 4 **DOES HEREBY ORDAIN** as follows: 5 **SECTION 1.** Pursuant to Government Code Section 51179(b)(1), and based 6 upon substantial evidence in the record, the City Council finds that the requirements of 7 Government Code Section 51182 are necessary for effective fire protection within the 8 Wrightcrest neighborhood and the lower Culver Crest neighborhood in the City. 9 SECTION 2. Section 9.02.400 of the Culver City Municipal Code is hereby 10 11 amended and restated in its entirety to read as follows: 12 13 VERY HIGH, HIGH, AND MODERATE FIRE HAZARD SEVERITY ZONES 14 § 9.02.400 DESIGNATION OF VERY HIGH, HIGH, AND MODERATE FIRE 15 HAZARD SEVERITY ZONES. 16 A. The City Council designates Very High, High, and Moderate Fire 17 18 Hazard Severity Zones (FHSZs) as recommended by the Culver City 19 Fire Department on a map entitled, Very High, High & Moderate 20 FHSZs – Culver City, and dated May 2025, increasing the levels of 21 certain FHSZs and adopting other FHZS as identified by the California 22 Department of Forestry and Fire Protection. 23 Β. The Culver City Fire Department's Very High, High, and 24 25 Moderate FHSZs designation map shall be kept on file in the City 26 Clerk's office and in the Fire Prevention Division offices. 27 28 -3-

SECTION 3. In amending and restating in its entirety Section 9.02.400 of the Culver City Municipal Code, the City Council is hereby adopting the Fire Hazard Severity Zones of Very High, High, and Moderate, as recommended by the Culver City Fire Department, identified on a map dated May 2025, attached hereto as Exhibit "A." This map increases the FHSZs for the Wrightcrest and lower Culver Crest neighborhoods to Very High and adopts the remaining FHSZs as identified by the State Fire Marshal on the California Department of Forestry and Fire Protection's map dated March 24, 2025, attached hereto for comparison as Exhibit "B."

SECTION 4. Pursuant to Section 619 of the City Charter, this Ordinance shall take effect thirty (30) days after its adoption. Pursuant to Section 616 and 621 of the City Charter, prior to the expiration of 15 days after the adoption, the City Clerk shall cause this Ordinance, or a summary thereof, to be published in the Culver City News and shall post this Ordinance or a summary thereof in at least three places within the City. Further, pursuant to California Government Code Section 51179(c), the City shall transmit a copy of this Ordinance to the State Board of Forestry and Fire Protection within 30 days of adoption.
