

**ORDINANCE NO. 2025 - \_\_\_\_\_**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CULVER CITY, CALIFORNIA, ADOPTING VERY HIGH, HIGH, AND MODERATE FIRE HAZARD SEVERITY ZONES BY AMENDING AND RESTATING IN ITS ENTIRETY SECTION 9.02.400 OF THE CULVER CITY MUNICIPAL CODE REGARDING THE DESIGNATION OF VERY HIGH, HIGH, AND MODERATE FIRE HAZARD SEVERITY ZONES.

**WHEREAS**, pursuant to California Government Code Section 51178, the State Fire Marshal is required to identify areas in the State as Moderate, High, and Very High Fire Hazard Severity Zones (FHSZ) based on consistent statewide criteria and the severity of fire hazard that is expected to prevail in those areas; and

**WHEREAS**, the State FHSZ maps are being updated to more accurately reflect zones in California that are susceptible to wildfire through the incorporation of new science in local climate data and improved fire assessment modeling in determining hazard ratings; and

**WHEREAS**, on March 24, 2025, the Office of the State Fire Marshal (OSFM) issued the 2025 Recommended Local Responsibility Area (LRA) FHSZ map for Culver City - Los Angeles County, identifying certain Very High, High, and Moderate Fire Hazard Severity Zones in the City's LRA; and

**WHEREAS**, pursuant to California Government Code Section 51178.5, the City of Culver City (“City”) made the draft updated FHSZ map recommendations available for public review and comment within 30 days of receiving them; and

1                   **WHEREAS**, pursuant to California Government Code Section 51179(a), the  
2 City must designate, by ordinance, moderate, high, and very high FHSZs in its jurisdiction  
3 within 120 days of receiving recommendations from the State Fire Marshal; and

4                   **WHEREAS**, pursuant to California Government Code Section 51179(b)(3),  
5 the City is prohibited from decreasing the level of fire hazard severity zones identified by  
6 the State Fire Marshal for any area within the City, for example by reducing areas  
7 designated as very high FHSZs by the State Fire Marshal to moderate or high fire hazard  
8 severity zones; however, pursuant to California Government Code Section 51179(b)(1), the  
9 City may increase the recommended levels of FHSZs following a finding supported by  
10 substantial evidence in the record that the requirements of California Government Code  
11 Section 51182 are necessary for effective fire protection within the area; and  
12

13                   **WHEREAS**, the Culver City Fire Department (CCFD) is recommending  
14 increasing the State-recommended FHSZ designation for the Wrightcrest neighborhood, as  
15 well as for the lower Culver Crest neighborhood, which are currently already within Very  
16 High FHSZs; as such, property owners in those areas will not have new requirements; and  
17

18                   **WHEREAS**, during Santa Ana wind events, when the hot, dry air is blowing in  
19 off the deserts, fueling potential wildfire starts, the aforementioned neighborhoods are  
20 among the most vulnerable within the City's jurisdiction; thus, by continuing to attach the  
21 Very High designation to these areas, it will allow CCFD to better manage the City's brush  
22 clearance and help CCFD enforce 100 feet of defensible space around structures; and  
23

24                   **WHEREAS**, the City Council desires to adopt the CCFD's recommended  
25 FHSZ designations, which increase certain State-recommended FHSZs and adopt other  
26 State-recommended FHSZs, by amending and restating in its entirety Section 9.02.400 of  
27

1 the Culver City Municipal Code (CCMC), which was previously adopted by the City in 2012  
2 when only Very High FHSZs were required to be approved by ordinance.

3 **NOW, THEREFORE**, the City Council of the City of Culver City, California,  
4 **DOES HEREBY ORDAIN** as follows:

5 **SECTION 1.** Pursuant to Government Code Section 51179(b)(1), and based  
6 upon substantial evidence in the record, the City Council finds that the requirements of  
7 Government Code Section 51182 are necessary for effective fire protection within the  
8 Wrightcrest neighborhood and the lower Culver Crest neighborhood in the City.  
9

10 **SECTION 2.** Section 9.02.400 of the Culver City Municipal Code is hereby  
11 amended and restated in its entirety to read as follows:

12  
13 ***VERY HIGH, HIGH, AND MODERATE FIRE HAZARD SEVERITY ZONES***

14 **§ 9.02.400 DESIGNATION OF VERY HIGH, HIGH, AND MODERATE FIRE**  
15 **HAZARD SEVERITY ZONES.**  
16

17 A. The City Council designates Very High, High, and Moderate Fire  
18 Hazard Severity Zones (FHSZs) as recommended by the Culver City  
19 Fire Department on a map entitled, Very High, High & Moderate  
20 FHSZs – Culver City, and dated May 2025, increasing the levels of  
21 certain FHSZs and adopting other FHZS as identified by the California  
22 Department of Forestry and Fire Protection.  
23

24 B. The Culver City Fire Department's Very High, High, and  
25 Moderate FHSZs designation map shall be kept on file in the City  
26 Clerk's office and in the Fire Prevention Division offices.  
27  
28

1                   **SECTION 3.** In amending and restating in its entirety Section 9.02.400 of the  
2 Culver City Municipal Code, the City Council is hereby adopting the Fire Hazard Severity  
3 Zones of Very High, High, and Moderate, as recommended by the Culver City Fire  
4 Department, identified on a map dated May 2025, attached hereto as Exhibit "A." This map  
5 increases the FHSZs for the Wrightcrest and lower Culver Crest neighborhoods to Very  
6 High and adopts the remaining FHSZs as identified by the State Fire Marshal on the  
7 California Department of Forestry and Fire Protection's map dated March 24, 2025,  
8 attached hereto for comparison as Exhibit "B."  
9

10                   **SECTION 4.** Pursuant to Section 619 of the City Charter, this Ordinance shall  
11 take effect thirty (30) days after its adoption. Pursuant to Section 616 and 621 of the City  
12 Charter, prior to the expiration of 15 days after the adoption, the City Clerk shall cause this  
13 Ordinance, or a summary thereof, to be published in the Culver City News and shall post  
14 this Ordinance or a summary thereof in at least three places within the City. Further,  
15 pursuant to California Government Code Section 51179(c), the City shall transmit a copy of  
16 this Ordinance to the State Board of Forestry and Fire Protection within 30 days of  
17 adoption.

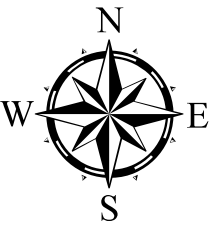

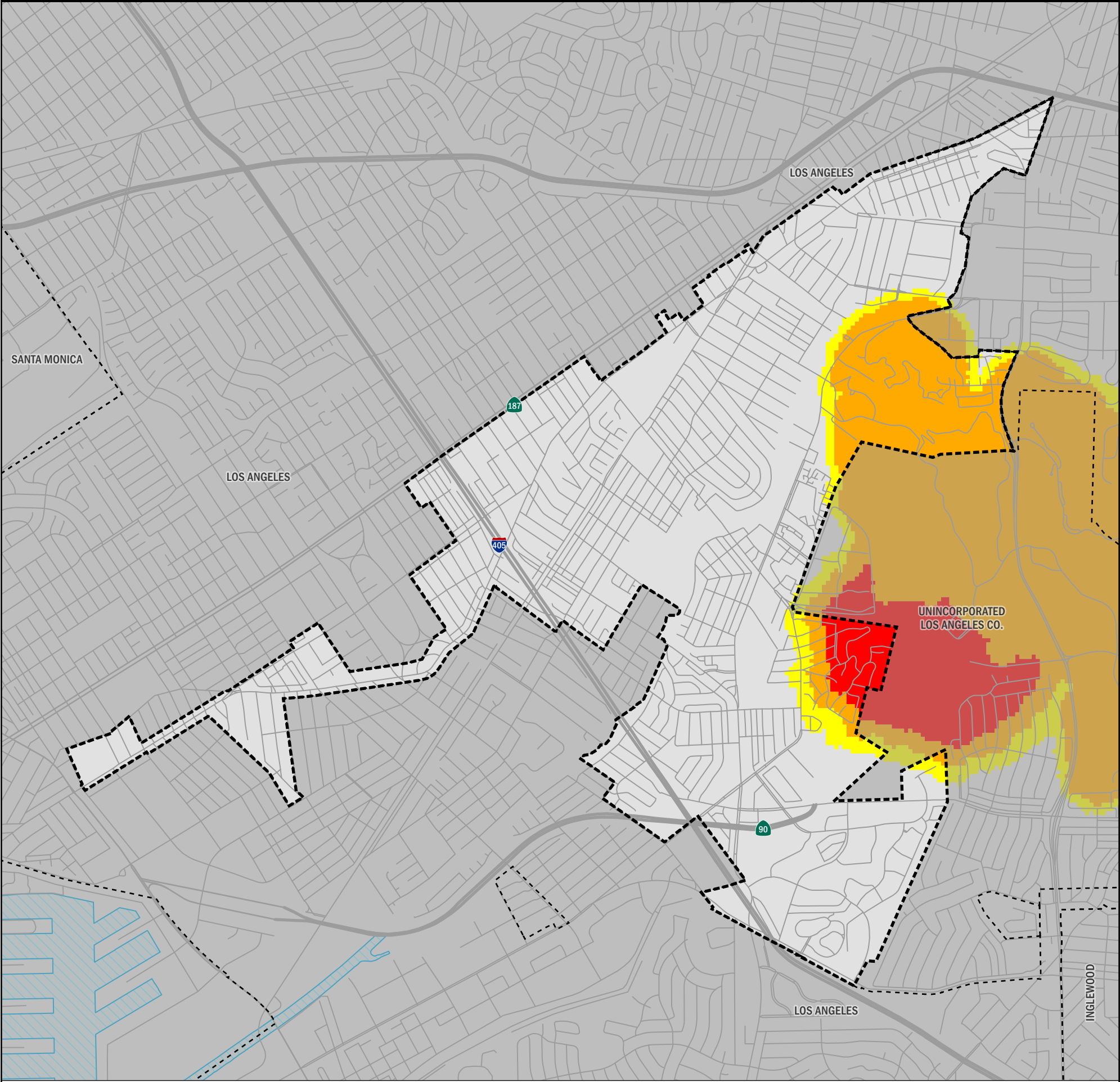

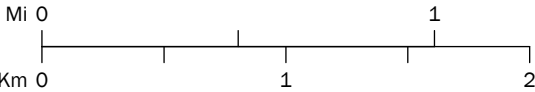
# Local Responsibility Area Fire Hazard Severity Zones
