THE CITY

Culver City is a Charter City incorporated in 1917, and is a destination filled with outdoor cafes, unique shops, and galleries opening onto pedestrian-friendly boulevards. Culver City has a dedicated staff of approximately 800+ employees with an overall operating budget of over \$325 million. The City provides a full range of municipal services, including Fire, Police, Community Development, Public Works, Parks, Recreation, Community Services, and Transportation.

THE POSITION

This posting is for current City employees only.

The following tasks are essential for this position. Incumbents in this classification may not perform all of these tasks, or may perform similar related tasks not listed here.

- 1. Paints pavement markings including legends, school crossings, <u>curbs</u>, and crosswalks, while operating a flatbed truck with airless spray unit, airless spray gun, and stencils.
- Paints City curbs to regulate parking, utilizing a flatbed truck with airless unit, and an airless spray gun.
 Paints traffic lines while operating a self-propelled line striper with airless spray unit and regulators.
 Properly cleans the equipment, flushing out all hoses and spray guns and cleaning and lubricating the automatic spray guns. Makes minor repairs.
- 3. Installs and repairs signs, replacing defective, destroyed, or damaged traffic signs, and placing new traffic signs to regulate, safeguard, and expedite traffic. Utilizes post hole digger, shovels, digging bars, brooms, ladders, and other hand and power tools.
- 4. Fabricates Installs regulatory signs for traffic control and direction. Correctly lays out stencils for street painting letters on the sign blank.
- 5. <u>Lays out Arranges</u> regulations traffic lines on new <u>City streets</u>, <u>checking checks</u> and readings blueprints approved by the City Engineer. Utilizes ropes, paints traffic dots to guide the street striping operation;, measuresing all traffic lane lines according to the blueprint specifications.
- 6. Installs traffic directional pavement buttons utilizing epoxy and placing the pavement buttons in accordance with the specifications and blueprints developed by the City Engineer.
- 7. Paints traffic lines in <u>City parking lots and , touch-up paints tennis and basketball various sport courts lines</u>, utilizing <u>a</u> traffic line striper.
- 8. Thins and mixes paints to proper consistency to enable the effective application. <u>Lays outArranges</u> job sites, placing safety signs and devices sufficient to protect all members of the crew.
- 9. Performs routine and light maintenance of equipment including cleaning and maintaining paint spray outfits, brushes, templates, stencils, paint truck and other equipment.
- 9.10. Sets-up public right-of-way safety controls, as appropriate, utilizing the most current safety protocols, including those outlined in -per-the traffic control industry's MUTCD and WATCH manuals.

Minimum Requirements

Any combination equivalent to training and experience that could likely provide the required knowledge, skills and abilities would be qualifying. A typical way to obtain the knowledge, skills and abilities would be: graduation-from high school or equivalent and three years of semi-skilled work experience, preferably in painting

EXAMINATION PROCEDURES

Applicants must receive a passing score on all of the examination components in order to be placed on the eligible list.

- Written Test (weighted at 30%): To measure knowledge of general labor and painting tasks. (Tentatively scheduled for the week of August 11, 2025)
- Performance Test (weighted at 40%): To demonstrate ability to follow directions and perform painting tasks. (Tentatively scheduled for the week of September 1, 2025)
- Appraisal Interview (weighted at 30%): To evaluate training, experience and personal qualifications. (Tentatively scheduled for the week of September 8, 2025)

ADDITIONAL INFORMATION
