With a population of just over 40,000 residents, Culver City strikes a unique balance between small-town charm and big-city innovation. In addition to its cultural and economic significance, Culver City has established itself as a leader in local governance and civic engagement. The City is deeply invested in shaping public policy that reflects the needs and aspirations of its residents and businesses. Through proactive legislation and policy advocacy, Culver City addresses a broad range of issues, including environmental sustainability, affordable housing, public safety, equity, and transportation. The City Council and various commissions, committees and boards work collaboratively with community stakeholders, regional agencies, and lawmakers to influence decision-making at all levels of government.

Culver City's approach to legislation and advocacy is rooted in transparency, inclusivity, and long-term vision. Whether by adopting local ordinances or engaging in broader policy advocacy efforts, the City consistently seeks to champion initiatives that enhance quality of life and promote equity. This commitment positions Culver City not just as a municipality but as a forward-thinking model of civic responsibility and innovation.

~~Legislative and Policy Program Overview~~

~~The primary objective of the Platform is for the City Council to adopt official City positions on specific legislative issues and policies. By doing so, the City Council's approval process is streamlined, because the City Council is providing clear direction to staff on pertinent legislative issues when determining the City's stance on legislation. The Platform is developed and maintained using based on the City Council's goals and objectives and incorporates guiding principles. It is shaped by input from both the City Council and staff.~~

~~The of~~The City may support legislation that aligns with the Platform, while legislation that conflicts with the Platform may be opposed. At times, the City will support the legislative positions of its partner organizations. However, there may be instances where the City does not support a specific position taken by a partner organization. In such cases, City staff will use the principles and goals outlined in this Platform to guide the City's position.

When the City supports or opposes legislation based on the Platform, City staff will prepare position letters to be approved and signed by the Mayor. Legislation not addressed in the Platform may require further direction from the City Council. Generally, legislative priorities focus on issues directly related to or impacting the provision of municipal services.

Federal, state, and regional legislative proposals, principles, and policies consistent with the Platform may be supported by the City. Those policies or proposals inconsistent with this agenda may be opposed by the City. For proposed legislation, either consistent with the Platform or consistent with positions the City has taken in the past, City staff shall be authorized to prepare position letters for the Mayor's signature. In the absence of the Mayor, the Vice Mayor may sign position letters on behalf of the City. If any City Council Member chooses to transmit their position on any issue as an individual Council Member, they must clearly state they are not addressing the issue on behalf of the City Council or the City.—~~

The Platform priorities included herein are principally intended to provide direction on matters that affect the funding, programs, projects, and operations of the City of Culver City as a municipal organization; however, the City may advocate a position on current social or international issues, if directed to do so by the City Council. While the City Manager's Office is primarily responsible for legislative issues, City departments should monitor and be knowledgeable of any legislative issues related to their discipline. Any requests for the City to take a position on a legislative matter must be directed to the City Manager's Office. City departments may not take positions on legislative issues without the City Manager's Office review and approval, particularly since the Mayor signs all position letters on behalf of the City. The City Council must give its majority consensus to request staff to agendize taking a position on any non-Culver City ballot measure.—~~

Guiding Principles**Preserve Local Control**

Preserve and protect the City's powers, duties, and prerogatives to enact local legislation and policy direction concerning local affairs and oppose legislation that preempts local authority. Local agencies should preserve authority and accountability for revenues raised and services provided. The City supports efforts to protect and/or expand the City's authority and rights over its municipal affairs. The City opposes efforts that preempt the current authority possessed by the City and delegate that authority to federal, state or other government agencies, or American Indian tribes unless it clearly promotes the City's policy goals, consistent with the Legislative and Policy Platform, or is required by federal or state law.

The City's basic principles are to: retain the City's self-governance; promote fiscal stability, predictability, financial independence, and preserve the City's revenue base and maximum local control over; and support funding opportunities through collaboration with municipalities, local government budgeting. Oppose measures that shift local funds to county agencies, special districts, regional governmental agencies, organizations, and local, state or, federal governments and/or make cities more dependent on county, state or federal governments for financial stability, such as unfunded mandates or mandated costs with no guarantee of local reimbursement or offsetting benefits.

- Maintain City reimbursements for personnel costs paid to public safety employees for training and required appearances in state and/or county courts.
- Continue the availability of regional healthcare facilities, such as Southern California Hospital at Culver City; Cedars-Sinai Urgent Care facility; UCLA Behavioral Health Associates - West Washington; and Didi Hirsch Mental Health Services.

- Continue to identify mental health resources available through partnerships, such as the Los Angeles County Department of Mental Health, and local nonprofit organizations for response, care and treatment of individuals in need. Pursue opportunities for new mental health programs.
- Provide federal and state funding, and grants that support the creation of and maintenance of existing affordable housing within the City.
- [Implement a system-wide process to ensure fair access to homelessness assistance, assessment, prioritization and referrals helping people experiencing a housing crisis get connected to resources efficiently.](#)
- [Explore local and Westside Cities trust funds that may be eligible for, but not limited to, the production or preservation of affordable housing/services through the acquisition, construction, reconstruction, and/or rehabilitation of non-luxury housing with suitable amenities.](#)
- Raise the funding levels and allowable fair market rents for the City's federal Section 8 Housing Choice Voucher Program to improve access to rental housing units by low-income households and increase the number of households served.
- Reduce homelessness and increase services to unhoused individuals both locally and regionally.
- Increase funding for projects and programs to provide housing and supportive services to unhoused individuals.

- Participate in the County's effort to combat homelessness and further explore and collaborate with the County to identify and enhance support available for community members who are experiencing homelessness.

Environment and Sustainability

ADVANCE ENVIRONMENTAL SUSTAINABILITY AND CLIMATE ACTION

Water Conservation, Water Quality, and Air Quality

Support efforts to:

- Seek the expanded use of recycled water, through stormwater activities and environmentally sustainable water recovery from reclaimed water.
- Identify and fund City water conservation programs to reduce demands on the local water supply.
- Conserve water and increase a sustainable, affordable, local water supply for Culver City.
- Continue partnerships to advance recycling, groundwater cleanup, and stormwater capture as the primary goals for the community's future water portfolio.
- Invest in projects and partner with businesses to improve water use-efficiency to help meet new demands.

- Adopt reasonable environmental regulations aimed at enhancing air and water quality, reducing stormwater pollution, and providing opportunities for corresponding funding mechanisms.
- Ensure that Total Maximum Daily Load (TMDL) requirements, which represent the maximum amount of a pollutant that a water body can receive and still meet water quality standards, are achievable and cost-effective. Also, support efforts to provide the resources necessary to meet TMDL requirements.

- Protect municipalities from litigation if they are making good faith efforts to meet TMDL requirements.
- Increase the City's ability to comply with environmental regulations.
- Improve air quality in Culver City and surrounding areas.
- Help municipalities plan for and fund an array of fuel vehicle infrastructure (including electric and hydrogen).
- Conduct greenhouse gas inventories, climate action plans, and other work that will help further the goals of AB 32, the Global Warming Solutions Act of 2006, and related legislation.

- Prioritize public health and safety and the environment, including protection of air quality and groundwater resources.
- Support the Geologic Energy Management Division (CalGEM) with its ongoing rulemaking efforts that prioritize protecting public health, safety, and the environment, including establishment of health protection zones, and supporting operator financial responsibility in its oversight of the oil, natural gas, and geothermal industries in California.
- Ensure that oil and gas wells are properly plugged and abandoned, that oil and gas premises are adequately remediated and restored to near natural conditions as practicable and that oil lease decommissioning costs remain the financial responsibility of the oil operators [and property owners, as applicable](#).

Energy

- Provide complete transparency of all energy procurement practices, stranded costs, and departing load charges.
- Achieve fair competition in statewide energy markets for CCAs and municipal or other publicly owned utilities.
- Adopt legislation and regulatory policies that protect CCA customers from excessive or improper cost allocation.
- Leverage energy-related programs tailored to address local needs and concerns effectively.
- Promote funding to advance renewable carbon-free power production, power storage and green energy technologies as well as conservation programs such as energy efficiency upgrades to public and private facilities.
- Promote customer installation of solar, wind, geothermal, energy storage, micro hydro, or other carbon-free renewable energy and offset their cost by including a full retail rate credit for the energy they generate that is equivalent to their use of electricity.

- Adopt building codes that meet California—required decarbonization and energy efficiency requirements for new construction and when existing buildings undergo major remodeling or expansion.

Aircraft Overflights
