20	1. The filing of an application with GameTime for playground funds for the
21	Project is hereby approved; and
22	2. The City of Culver City hereby certifies that it has or will have available,
23	prior to the commencement of any work on the Project included in this application,
24	the required match and sufficient funds to complete the Project; and
25	3. The City of Culver City hereby certifies that it has or will have sufficient
26	funds to operate and maintain the Project; and
