3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
4 CULVER CITY, CALIFORNIA, APPROVING AN  
5 APPLICATION FOR GRANT FUNDS FROM CALIFORNIA  
6 STATEWIDE EDUCATION AND FUNDING INITIATIVE  
7 THROUGH GAMETIME.

8 WHEREAS, California Parks and Recreation Society (CPRS), GameTime,  
9 PlayCore, Great Western Recreation, and MRC Recreation are partnering to improve the  
10 quality of life in communities through a Statewide Healthy Play Initiative; and

11 WHEREAS, GameTime supports CPRS's mission to provide and promote  
12 exceptional education, networking, and resources for all professionals in the California  
13 park, recreation, and conservation communities; and

14 WHEREAS, GameTime is offering funding to CPRS members to establish  
15 National Demonstration Sites that prioritize inclusion, nature integration, physical activity,  
16 and adult fitness; and

17 WHEREAS, if the application is approved by GameTime, the City of Culver  
18 City will enter into a contract with the GameTime to provide funds for the Culver West  
19 Alexander Park playground rehabilitation (the "Project").

20 NOW, THEREFORE, the City Council of the City of Culver City DOES  
21 HEREBY RESOLVE:

22 1. The filing of an application with GameTime for playground funds for the  
23 Project is hereby approved; and

24 2. The City of Culver City hereby certifies that it has or will have available,  
25 prior to the commencement of any work on the Project included in this application,  
26 the required match and sufficient funds to complete the Project; and

27 3. The City of Culver City hereby certifies that it has or will have sufficient  
28 funds to operate and maintain the Project; and

4. The City of Culver City hereby certifies that it has reviewed, understands, and agrees to the provisions contained in the contract shown in the Grant Application; and

5. The City of Culver City hereby agrees to comply with all applicable federal, state and local laws, ordinances, rules, regulations and guidelines; and

6. The City Council hereby appoints the City Manager, or his designee, to conduct all negotiations, and to execute and submit all documents including, but not limited to, applications, agreements, amendments, payment requests and so forth, which may be necessary for the completion of the aforementioned project.
