1) Deaccession a Permanent Artwork, "Sentry", by John Okulick at 4040 Duquesne Avenue; 2) Provide Comments; and, 3) Make Recommendation to the Cultural Affairs Commission

Sam Lee, Cultural Affairs Analyst, provided a summary of the material of record.

Discussion ensued between staff and Subcommittee Members regarding regular recommended maintenance; lack of communication with the artist; difficulty salvaging artwork; the popular trend of fountains in the 1990s; putting in something new to refresh the space; the recommendation to the Cultural Affairs Commission; the deaccession process; the process for a creating a new installation; involvement of the Culver City Police Department (CCPD) in the artist selection process; the general timeline; instigation of the deaccession; rationale for the deaccession; confirmation regarding the cultural significance or lack thereof, of the artist or the piece; maintenance fees; the public process; following guidelines; transparency; the need for a statement of value; use of the ramp by skateboarders; damage to the tiles; the current state of disrepair; the process for public notification; the City-owned artwork; notification rather than discussion; the project budget; re-configuring the area; the dated piece; the original intent of the water feature; support for a recommendation that deaccession goes to the full Commission for consideration; concern with taking someone's work for granted; the need for a report indicating there is no significant value; subjectivity; cost issues; the larger

Cultural Affairs Commission Public Art Subcommittee June 11, 2024 Page 3 of 5 conversation about the Culver City-owned public art collection; money to conserve artwork that needs major restoration; consideration of deaccessioning pieces in Culver City due to major cost issues and the inability to restore all pieces to their original function; usable life of the pieces; opening space for new projects; staff agreement to provide information about how the deaccession came about and the rationale for deaccession to the Subcommittee prior to meeting with the full Commission; inclusion of a reference to upcoming deaccessions to clean Culver City up for the Olympics and to make way for more well-known artists; and the opportunity to engage in a thoughtful deaccession.

Items from Members/Staff

Discussion ensued between staff and Committee Members regarding the municipal code; developer fees; the Supreme Court; guidance from the Legal Department before moving forward; follow up with Beau Basse on an artist he had previously presented to the Subcommittee; the timeline for spending Cultural Trust funds; AB1600; the parameters around how Cultural Affairs is funded; support for providing a presentation to the full Commission; confirmation that Sam Lee's contract was extended; support for work to make the position permanent; a suggestion that Lee Lawlor provide a report on the recent Creative Economy Report at Sony for the next Commission meeting; Performing Arts as the leading indicator of growth; use of empty buildings for pop-ups; the shifting economy; creating a local competition for a vinyl wrap of electric boxes leading up to the Olympics; electric boxes in Los Angeles vs. those in Culver City; creating a simple process; challenges with storefront art programs; involvement of the Artist Laureate; Olympics Subcommittee meetings; park areas where wraps would be appropriate; City branding; City communication; building the templates; the World Cup; formulation of a budget in order to make a pitch for funding; Public Art; flexibility with the Temporary Art budget; Capital Improvement Projects (CIPs); partnerships; Olympics funding; other surfaces to wrap; art pop-ups; Instagrammable installations; easing people into more permanent artwork in underserved areas; creating a menu of pre-designs and artists; providing continuity; length of the installation; and making art available to developers with temporary beautification needs.
