- **Inter-Agency Agreement with the Housing Authority of the City of Los Angeles (HACLA)**
  - Consider enter into an Inter-Agency Agreement with HACLA to allowed Culver City Section 8 Voucher Holders to lease units within one mile of the Culver City border in the HACLA jurisdiction. This will allow for greater access to rental units within the Section 8 Payment Standard and prevent voucher holders from risk of relinquishing voucher or relocation outside the Westside of Los Angeles
