RECOMMENDATION: Staff recommends the City Council authorize the submittal of a grant application requesting \$800,000 in American Recovery and Reinvestment Act (ARRA) funds through the Clean Water State Revolving Fund (CWSRF) for City-wide installation of catch basin trash removal inserts. BACKGROUND: On February 17, 2009, President Barack Obama signed into law the American Recovery and Reinvestment Act (ARRA). This \$787 Billion economic stimulus package includes \$355 Billion in funding for transportation, infrastructure, construction, healthcare programs, education, housing assistance, and energy efficiency projects, \$144 Billion in State and Local Fiscal Relief and \$288 Billion in tax credits. ARRA funds will be issued through grants and loans for specific funding categories administered by existing grant agencies. DISCUSSION: The ARRA is providing \$6 Billion nationwide for <i>Clean Water and Drinking Water Grants and Loans</i> and \$281 Million has been allocated for projects in California to fund “shovel-ready” projects. The State Water Resources Control (SWRCB) will administer the grant and loan program through the <i>Clean Water State Revolving Fund</i> (CWSRF). Eligible projects include sewer facilities, water recycling facilities, storm water quality improvement, and estuary conservation and management.

Funding would be provided on a reimbursement basis and no local match is required.

Proposed Project - It is recommended that the City submit a grant application for ARRA/CWSRF funding for the installation of Catch Basin Trash Removal Inserts on 325 catch basins citywide. Catch basin trash removal inserts are screens inside catch basins and along catch basin openings that capture all trash larger than 5mm in diameter as mandated by the Ballona Creek Trash Total Maximum Daily Load (TMDL). It is estimated that this project will cost \$800,000.

It should be noted that staff is pursuing another project to install catch basin trash capture inserts in 672 catch basins through a grant project funded by Proposition 50. The recommended grant application addresses the remainder of catch basins in Culver City not receiving inserts under the proposition 50 project.

Application Process - The State Water Resources Control Board has set a March 24, 2009 deadline to place projects on the Clean Water State Revolving Fund (CWSRF) priority list to apply for funding. This is an on-line application process and staff has drafted the applications and is ready to submit them upon Council authorization. Full hardcopy applications will be prepared and submitted by staff after completion of the on-line application.

SWRCB staff indicates it is their goal to enter into grant agreements addressing 50% of ARRA funds by August 2009 with the ultimate goal of having 50% of the ARRA funding encumbered to construction contracts by February 2010. The remainder of funding would be committed to agreements in 2010.

FISCAL ANALYSIS:

There is no fiscal impact caused by submittal of the grant application. The grant funding would be provided on a reimbursement basis and no local match is required. If the grant is received, design and construction will be performed by consultants and contractors. Project management will be provided by Public Works Environmental Program and Operations Division staff without the need for additional staff. Staff will return to the City Council to authorize acceptance of the grant and to amend the adopted budget to incorporate the funds.

MOTIONS:
