Discussion ensued between staff and Committee Members regarding the historical markers exhibit; the QR code; the importance of making the public aware of historical facts;

business owners in the Culver City area that want to participate next year; positive feedback received; attendance levels; improving on the time the food is served; glare that made it hard to see the In Memoriam display; speed of the slides in the display; the passport system; the date range that Culver City was considered a Sundown Town; a suggestion to include a historical marker showing the realities of the consequences of slavery and Jim Crow; multiple layers and factors regarding incarceration; concern with displaying statistics without context; previewing educational material prior to printing; facts that were not shared with the Committee in advance; concern that not everyone was on the same page with the educational information that was given at the event; the need for full Committee review of educational material; information left out regarding the history of the event; a recommendation that the full Committee review information before items go to press; jurisdiction; and the missed opportunity to take advantage of Committee expertise.

Additional discussion ensued between staff and Committee Members regarding information shared months prior to the event; the addition of the graphics and the date range for the Sundown slide by PRCS; approval of the concept by the full Committee, not the details; the need to improve security; positive feedback on food quality and vendor; concern with the length of the food lines; having pre-made plates; the need for multiple food trucks to accommodate the scale; the children's table; relocation of the children's area due to difficulty of hearing the books being read; the importance of providing water, food, and a space for the entertainers; mic checks; ensuring there are no audio issues; concern that there was no water available for entertainers and attendees; lack of knowledge about who the vendors were; assigning a lead to help manage vendor and entertainment contracts; the need for clarity on the budget; key items that were not done; the need for a clear run of show template including vendors, key contacts, being clear on who the audience is; promotional materials for the event using old and outdated images; the importance of allowing the Committee to review promotional materials before they are distributed; allowing the Committee to help distribute promotional materials; logistics; improvements that can be made to enhance the event; the importance of proactive communication to provide information when changes occur; receipt of information before the meeting; assignment of one

communications lead and one person to handle vendor logistics as a point of contact; the need for a reoccurring pre-event audit to review all marketing materials; creating a standard run of show template with flexibility for additions; and ensuring that people understand roles and responsibilities.

Discussion ensued between staff and Committee Members regarding clarification that the event was within the budget; having a running budget so the Committee knows where to push and pull; the need for an accurate run of show with accurate speakers; a suggestion to dissolve vaque ad hoc subcommittees and create more specific ad hoc subcommittees; subcommittee updates at each meeting; communication with staff to agendize subcommittee reports; information included in staff reports released 72 hours in advance of meetings; the need for one person to take the lead on a subcommittee to contact staff to get items on the agenda; success of the History and Culture Ad Hoc Subcommittee in scheduling regular meetings, sharing ideas, understanding roles and the topic; similar issues with the MLK event that were experienced with the Juneteenth event; ensuring that feedback from prior events is applied; creation of a handbook for each event with staff reports, Committee feedback, and attendance numbers; creation of a distribution list for events; staff agreement to include an attachment to the staff report when the presentation of statistics is made; linking the evite emails to the listserv; 1,500 signed up to receive email blasts; ensuring that people are aware of events and proclamations; and the intent to increase promotion and improve the event.
