A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
CULVER CITY CALIFORNIA APPROVING THE
APPLICATION FOR A REGIONAL USED OIL BLOCK
GRANT IN CONJUNCTION WITH THE CITIES OF
BEVERLY HILLS AND WEST HOLLYWOOD

WHEREAS, the people of the State of California have enacted the
California Oil Recycling Enhancement Act which provides funds to cities and counties
for establishing and maintaining local used oil collection programs that encourage
recycling or appropriate disposal of used oil and

WHEREAS the California Integrated Waste Management Board has been
delegated the responsibility for the administration of the program within the state, setting
up necessary procedures governing application by cities and counties under the
program and

WHEREAS said procedures established by the California Integrated
Waste Management Board require the applicant to certify by resolution the approval of
the application before submission of said application to the state and

WHEREAS, it is beneficial for the Cities of West Hollywood Culver City
and Beverly Hills to file a regional application and

WHEREAS the applicant will enter into an agreement with the State of
California for development of the project

7 2 Authorizes the submittal of a regional application on behalf of the
8 cities of Culver City Beverly Hills and West Hollywood to the California Integrated
9 Waste Management Board for a 2006/2009 Used Oil Recycling Block Grant and

10 3 That the City of West Hollywood will serve as the regional grant
11 administrator during the 2006/2009 grant period
