12 procedures; and

13 WHEREAS, said procedures require the City of Culver City to certify, by
14 resolution, the approval of the application before submission of the application(s) to the
15 State; and

16 WHEREAS, the application is for grant funds for the City of Culver City's
17 Bicycle and Pedestrian Master Plan Update; and

18 WHEREAS, if the application is approved by the State, the City of Culver
19 City, as Lead Agency, will enter into an Agreement with the State of California to carry
20 out the development of the Projects.

23 1. The filing of an application with the California Department of
