Re: Request to Inspect and Obtain Copies of Initiative Petition Sections,
Lists of Disqualified Signatures, and Materials Used to Disqualify
Signatures

Dear City Clerk Bocchino:

As you know, our office represents Cass Gualvez, the proponent of an initiative proposal regarding increasing healthcare workers' minimum wage in Culver City. As the proponent's designated representative, I am writing to request inspection and copies of certain documents related to the initiative and petition.

On June 16, 2022, we received a copy of a letter and e-mail indicating that the initiative has insufficient signatures to qualify for the ballot. Based on the letter, there were 560 petition signatures that were deemed invalid and 20 duplicate signatures out of 3,344 signatures submitted.

Accordingly, we request access to inspect and to obtain copies of certain documents, as is our right under the California Constitution and the Public Records Act. (See Cal. Const., art. I, §3(b)(2); Cal. Gov't Code § 6253.5.) We believe that it would be in the best interests of all parties concerned and the public interest, to immediately schedule a meeting so that we may discuss the issues upon which signatures were challenged, to inspect and obtain copies of the petition sections containing the rejected signatures, and to inspect and obtain copies of the memoranda and materials used to determine that signatures were invalid. We request that such an inspection meeting commence at a mutually agreed upon time between June 23 and July 1.

As a preliminary matter, we request a list showing the rejection/challenge categories (e.g., different address, missing signatures, not registered to vote, outside of the City, mismatched signature, duplicate signatures etc.) and the number of signatures in each category. We also request to inspect and obtain copies of any lists containing the rejected signatures with the reasons for their rejection, copies of the petition sections containing the rejected signatures

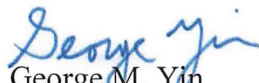

themselves together with copies of any materials (e.g., printouts, screenshots) from databases or other resources that were used to determine that a signature was invalid (including but not limited to materials which election officials used to determine signature mismatch, different address, that a voter lives outside the City, that a signature was a duplicate, and that a voter was not registered to vote, etc.) as is our right under California's Constitution and statutory law. (See e.g., Cal. Gov't Code § 6253.5.) We also request to view and to obtain copies of the information that was used for determining whether a petition signature matched a signature on an affidavit of voter registration and whether the voter was registered to vote at the address which they wrote on the petition. (See Cal. Elect. Code § 2194(a)(3), (c)(2).)

We believe that reaching clarity over the situation will benefit all concerned. We look forward to your response. We would be happy to discuss any aspect of this process with you. We would be happy arrange for photocopying or pay for any photocopying costs. If electronic versions of the documents that we request to inspect and copy are available or more practical to obtain/transmit, we request to discuss that option with you.
