Public Comment for Items NOT On the Agenda

Council Member Eriksson invited public comment.

The following members of the audience addressed the Subcommittee:

Sandrine Cassidy, Ballona Creek Renaissance, thanked the Subcommittee for their discussion on polystyrene at the last meeting; she urged the Subcommittee to consider a full ban of polystyrene; discussed the actions of other cities; the volatile recycling market; the burden on the businesses; alternatives; the number of businesses affected; the hardship burden in the ordinance; education; litter control; cities in California that have already

adopted the ban; actions necessary to be a green City; the problems that occur before the recycling process; and she indicated that Ballona Creek Renaissance was committed to helping.

Discussion ensued between staff and Subcommittee Members regarding staff efforts and continued consideration of the matter.

Deborah Gregory, Ballona Creek Renaissance, echoed comments made by Sandrine Cassidy.

Craig Cadwallader, Surfrider Foundation, reported that Pasadena had moved to ban polystyrene; discussed the lack of a market for polystyrene; costs for the recycling program in Pasadena; the pilot program; costs to the City; the result for the environment; fiscal responsibility; tangible financial results; different types of polystyrene; health issues; hardship clauses; recycling options; and he urged the City to enact a ban.

Charles Herbertson, Public Works Director, introduced two new staff members: Helen Chin and Kim Braun.

Discussion ensued between staff and Subcommittee Members regarding changes made to the draft survey; outreach; next steps in the process; survey results; and timing.

Item A-2

**Discussion of Best Practices for Waste Collection,
Processing and Recycling with the Aim to Reach a 75%
Diversion Rate Within a Few Years; and Eventually, Zero
Waste**

Council Member Eriksson discussed food waste; diversion rates; the test with the secondary Materials Recovery Facility (MRF); education; consideration of adding a second recycling center in the City; pricing as a control mechanism to encourage businesses to start using blue bins and green waste bins; diversion rates in Sweden; recycling instructions on packaging; putting stickers on the bins to educate; continued reminders and education; and the short-term goal of 75% with a long-term goal of 99%.

Discussion ensued between staff and Subcommittee Members regarding the current diversion rate; information from the state; state-wide standards; composting; food waste; logistical issues; restaurants and schools; clean food waste and clean recycling; expanding hazardous waste programs; dirty MRFing; commercial waste; the Climate Action Plan in the General Plan; setting the tone for all City policy; redesigning commercial and restaurant spaces; troubleshooting issues to consider the consequences of changes; partnering with businesses; deadlines to meet goals; actions of other cities; opportunities for new businesses; outreach opportunities; new technologies; space constraints; available options; using a two-can system; wet/dry waste; behavioral changes; digester use; and small textile recycling.

Discussion ensued between staff and Subcommittee Members regarding the amount of organic material in the black bin; subcommittee input; next steps in the process; and the Sustainability Plan and the General Plan.

Item A-3

Study the Addition of a Second Recycling Center

Catherine Vargas reported that David Voncannon had requested examination of adding an additional recycling facility in the City; she discussed previous experiences the City has had working with recycling facilities on grocery store property; and resident concerns with proximity to recycling facilities.

Discussion ensued between Subcommittee Members and staff regarding publishing the location of nearby recycling facilities to encourage use on the City website; concern with losing revenue to other facilities; CRV value; sustainability goals; the volatility of the market; the effects of recycling facilities on surrounding areas; and homeless services.

Set a Date to Tour CR&R's Anaerobic Digestion Facility in Perris, CA

Catherine Vargas, Public Works, discussed time required for the tour; distance to the facility; transportation; and potential dates.

Discussion ensued between staff and Committee Members regarding agreement to tour the facility on December 13; availability of the tour to staff and Council Members; transportation; publicizing the event to the public; and Brown Act issues.

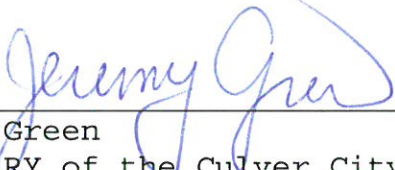
Discussion ensued between staff and Subcommittee Members regarding reinstatement of the page on the website; highlighting sustainability issues; and ease of access to information.

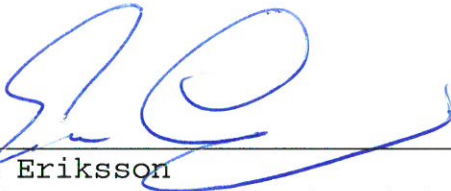
There being no further business, at 4:12 p.m., the Sustainability Subcommittee of the City Council adjourned its meeting to January 18, 2016.
