

1 adopted an ordinance, codified in Culver City Municipal Code Subchapter 15.02.1000 et
2 seq., establishing a mandatory 1kw solar photovoltaic requirement per 10,000 square feet
3 of new construction for commercial and multi-family projects; and

4 **WHEREAS**, Section 15.02.1015 of the ordinance established a waiver of the
5 fist \$5,000 of solar permit fees, which expired on March 12, 2018; and

6 **WHEREAS**, to continue to encourage solar photovoltaic installations, which
7 reduces the burning of fossil fuels and has other environmental benefits to the City, the
8 City Council desires to continue the fee waiver for an additional 10 years.

9 **NOW THEREFORE**, the City Council of the City of Culver City, California,
10 **DOES HEREBY ORDAIN** as follows:

11 **SECTION 1.** Based on the foregoing recitations and findings, Section
12 15.02.1015 of the Culver City Municipal Code is hereby amended as follows (underlined
13 text denotes additions, strikeout text denotes deletions):

14 **§ 15.02.1015 BUILDING PERMIT FEES AND INSPECTIONS.**

- 15 A. Plan check and permit fees in an amount not to exceed Five Thousand
16 Dollars (\$5,000) shall be waived for solar photovoltaic installations. This
17 subsection, 15.02.1015.A, shall remain in effect until ~~March 12~~May 23,
18 ~~2018~~2028, and as of that date is repealed, unless a later enacted statute,
19 enacted before ~~March 12~~May 23, 20182028, deletes or extends that date.

21 B. The value of the required solar photovoltaic system shall not be required to
22 be included in the overall construction valuation of the project for the
23 purposes of determining building permit fees.

25 C. No final inspection shall be approved for a construction project subject to the
26 requirements of this Subchapter, nor shall a temporary or final certificate of
27 occupancy be issued for such project, prior to the installation of the solar

photovoltaic system being completed, inspected and fully operational, unless otherwise excepted pursuant to Section 15.02.1010.

SECTION 2. Pursuant to Section 619 of the City Charter, this Ordinance shall take effect thirty (30) days after the date of its adoption. Pursuant to Sections 616 and 621 of the City Charter, prior to the expiration of fifteen (15) days after the adoption, the City Clerk shall cause this Ordinance, or a summary thereof, to be published in the Culver City News and shall post this Ordinance or a summary thereof in at least three places within the City.


