11 ***Collection Surcharge***

12 A \$25.00 surcharge will be added to any unpaid fine that is sent to a collection
13 agency for collection.

14 ***DMV Administrative Fee***

15 A \$3.00 administrative fee charged by the California Department of Motor Vehicles to
16 place a vehicle registration on hold for non-payment of a violation will be the
responsibility of the violator and will increase the violator's fine accordingly.
