2 therefore, reserves all of its rights under the Laws to challenge the applicability of AB 1x 26 to
3 the Culver City Redevelopment Agency and/or the City of Culver City in any administrative or
4 judicial proceeding; and

5 WHEREAS, all other legal prerequisites to the adoption of this Resolution have
6 occurred.

7 NOW, THEREFORE, the City Council of the City of Culver City DOES HEREBY
8 RESOLVE as follows:

9 1. The City Council of the City of Culver City hereby finds and determines
10 that the foregoing recitals are true and correct.

11 2. Subject to all reservations stated herein, the City of Culver City hereby
12 elects to become the successor agency to the Culver City Redevelopment Agency under
13 Health and Safety Code section 34173(a) and implement all duties of successor agencies
14 under Part 1.85 of Division 24 of the Health and Safety Code.

15 3. The City Manager, or his or her designee, is hereby authorized to
16 administer the responsibilities of the City of Culver City as the successor agency under Part
17 1.85 of Division 24 of the Health and Safety Code.

18 4. This Resolution shall take effect immediately upon its adoption.
