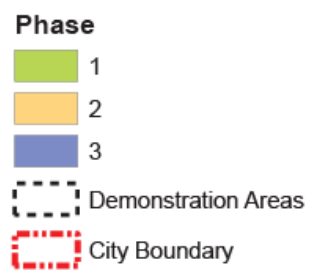

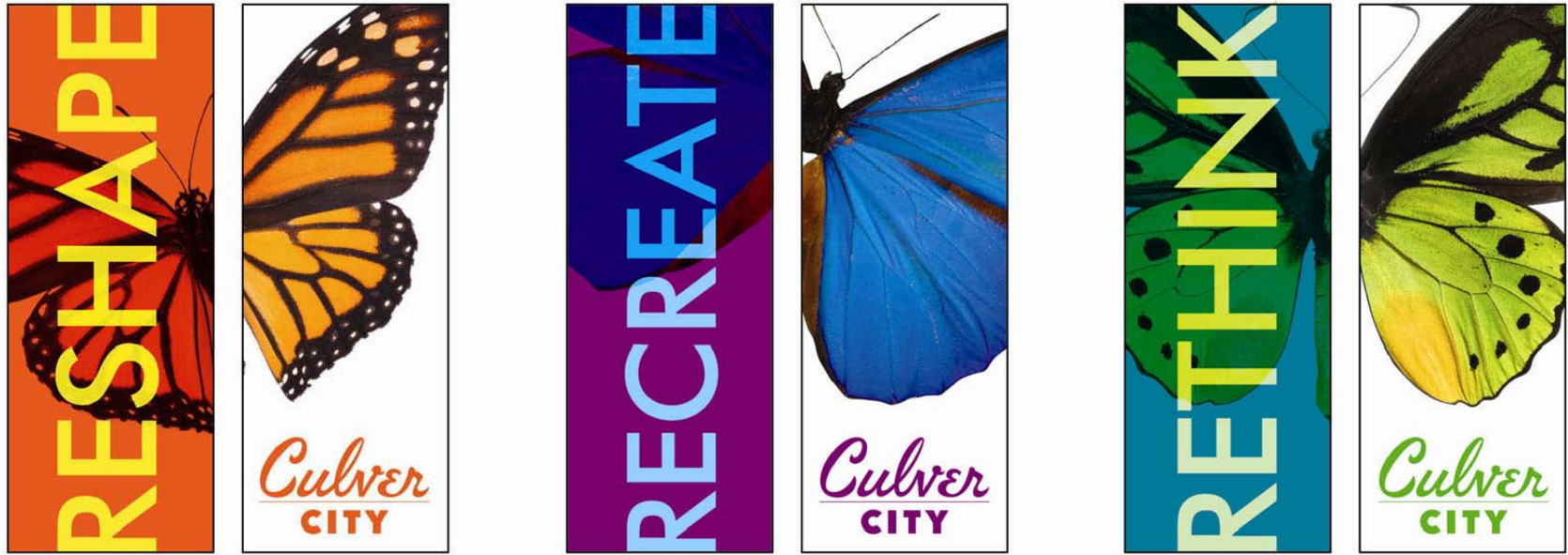

## AIP Petition

To the Culver City Redevelopment Agency:

We are business and/or property owners along West Washington Boulevard between Beethoven and Glencoe. We encourage the Agency to continue its efforts to revitalize west Culver City by creating an Area Improvement Program (AIP) encompassing our area.

We would like to see the Agency:

- 1) Install landscaped medians, and
- 2) Offer façade improvement grants

We are aware that property owners will need to vote in favor of a property tax assessment to pay for the ongoing maintenance of landscaped medians prior to their construction, and that an Agency façade improvement grant program would require a matching investment from property and/or business owners choosing to take advantage of it.

We believe that an AIP in our area will result in increased business activity and higher property values, and thus that it will be beneficial both to ourselves and to the City of Culver City.

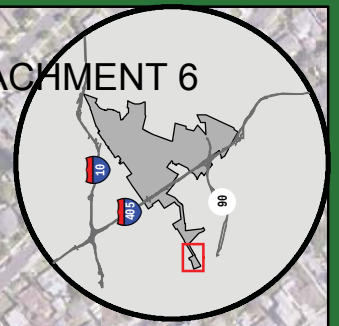
