

CULVER CITY DISTRICT TAXES HIGHLIGHTS

Culver City's voter-approved district taxes, Measures CC (.5%) and C (.25%), receipts from January through March were essentially even compared to the first sales period in 2023. However, after adjusting for reporting modifications such as audit corrections and delayed payments, actual sales were down 1.6% and 1.7%, respectively (slight variance due to taxpayer inconsistencies). Most tax groups declined compared to a year ago.

On the positive, as the district taxes' largest sales tax category, general consumer goods experienced a nearly 3% increase with stability in discount department store revenues and gains in family apparel, department stores and home furnishings sales (assisted by a new business) – as consumers enjoyed the experience of in-store and online shopping.

Grocery store sales increased (assisted by a new grocer), and a new business in the convenience stores-liquor sector bolstered overall food-drug receipts.

Conversely, restaurants-hotels experienced a slight decline, driven by the loss of several casual dining eateries. Residents pulled back on vehicle purchases for the fourth consecutive quarter as interest rates remained high, resulting in a 21% drop in new car sales.

Business-industry related results declined almost 14%, mostly due to comparison to one-time revenues a year ago. Lower contractor activity and building materials sales resulted in a contraction in building-construction.

Net of adjustments, taxable sales for all of Los Angeles County declined 0.8% over the comparable time period; the Southern California region was flat.


