3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 CULVER CITY, CALIFORNIA ORDERING THE
5 PREPARATION OF AN ENGINEER'S REPORT
6 PURSUANT TO THE PROVISIONS OF CHAPTER 15.01
7 OF THE CULVER CITY MUNICIPAL CODE AND
8 DECLARING ITS INTENTION TO ORDER THE ANNUAL
ASSESSMENT LEVY FOR THE ALBRIGHT AVENUE
STREETLIGHTING ASSESSMENT DISTRICT AND
SETTING THE TIME AND PLACE FOR THE PUBLIC
HEARING.

9 WHEREAS, the City Council of the City of Culver City desires to conduct
10 proceedings for considering the annual assessment of a benefit district pursuant to the
11 terms and provisions Section 15.01.070 of Chapter 15.01 of the Culver City Municipal
12 Code, in what is known and designated as the "ALBRIGHT AVENUE STREETLIGHT
13 ASSESSMENT DISTRICT;" and

15 WHEREAS, the City Council of the City of Culver City desires to complete the
16 proceedings for the annual levy of the assessments as required by Article XIII (C) and (D)
17 of the Constitution of the State of California (Proposition 218); and

19 WHEREAS, these proceedings for the annual levy of assessments shall
20 relate to the fiscal year commencing July 1, 2009 and ending June 30, 2010; and

21 WHEREAS, the provisions of Section 15.01.055, require a written Engineer's
22 Report consisting of the following:

- 23 1. A diagram of the area proposed to be assessed; and
24 2. An assessment of the estimated costs for said fiscal year.

1 NOW, THEREFORE, the City Council of the City of Culver City, DOES
2 HEREBY RESOLVE as follows:

- 3 1. The above recitals are true and correct.
- 4 2. The certain street lighting improvements were completed in March
5 2005 and are set forth in the Engineer's Report to be presented to this City Council for
6 consideration.
- 7 3. The City of Culver City hereby declares its intention to levy the annual
8 assessment on the 18 members of this assessment district for fiscal year 2009/2010.
- 9 4. The City Engineer is hereby ordered to prepare and file with the City
10 Clerk, for submission to the City Council, an Engineer's Report relating to said annual
11 assessment and levy in accordance with the provisions of Section 15.01.055 of the Culver
12 City Municipal Code.
- 13 5. Upon receipt of the City Engineer's report, and in accordance with the
14 provisions of Section 15.01.070 of the Culver City Municipal Code, the City Clerk is hereby
15 ordered to give notice of the time and place a public hearing will be held by the City Council
16 to consider objections and protests.
