Items from Commissioners/Staff

Ted Stevens, Parks, Recreation and Community Services Director, gave an update on incidents that took place within department programs over the last month, the department has held community meetings and parent meetings; the department has reviewed its procedures and policies and beefed them up a bit; staff training on the new policies and procedures; staff trainings; staff changes at all of the afterschool sites to bring in higher level part-time staff at those locations that will not be part of the ratio to child; more staff at each of the sites; in the meantime, full-time supervisors and coordinators will be assigned at all of the sites for the beginning of the programming until the new staff is on boarded; beefing up training doing a more thorough training before being

Action Items

Receipt and Filing of an Update about the Hours of the Paddle Tennis Courts Located at Elenda St. and Culver Blvd.

Chair Alexander reminded the public that the Commissioners could only discuss the hours of the court. They had received other comments and if there was a desire for the Parks, Recreation and Community Services Commission to agendize a future item, the Parks, Recreation and Community Services Commissioners will discuss that later in the meeting.

Ted Stevens, Parks, Recreation and Community Services Director provided a summary of the material of record.

Chair Alexander invited public comment.

The following members of the public provided public comment:

Yael Wyte discussed living very close to the courts and hearing the first ball each morning and the last ball each evening; believing that the current times are a reasonable time to play; mentioned the sound abatement has helped with the sound but does not help with the sound in her bedroom; mentioned when the gates are left open, players do come early and she does not wish to police that; requested the hours 8 A.M.-9 P.M. and courts continue to be locked outside of the times; mentioned she and her family love the sport, but that people should play it within reasonable hours.

Jospeh Kaplan was called to speak but was not present in Council Chambers or online. Chair Alexander requested staff call him again after everyone has spoken to see if he had joined the meeting.

Angelica Martinez was called to speak but was not present in Council Chambers or online

Joseph Feinberg discussed being a long-time player, learning and discovering pickleball, making friends, and being called the mayor of the Culver City courts; the importance of building community; advocate for Culver City and spending time in Culver City; hates Santa Monica but that is where he plays pickleball now; when looking for a restaurant or a bar to go to, he is looking in Santa Monica and not Culver City; people are looking for places to play, and he cannot get to Culver in time to

play after work; if he can't get to the courts by 7 then there is not a reason to play in Culver; the communities are developing and the tax dollars being spent are going to other cities.

Barry Goldstein lives near the courts; reiterated that the hours have been an excellent compromise; the sound abatement has reduced the sound by about a third; it is not the noise as much as the gathering that is irritating; love the game and the courts; it is a question of compromise between competing principles; the recent movement from 9 A.M. to 8:30 P.M. was a bit distressing; the neighbors wish to remain these hours; would be willing to entertain a trading system for courts to open later on the weekend and stay open later a few nights during the week; requested the PRCS department to look into automatic locking gates.

Andy Gauvreau was called to speak but was not present in Council Chambers or online.

David Van Slyke requested three minutes instead of two, and Chair Alexander reminded him that everyone has the same amount of time to speak so he would only have two minutes; showed the municipal court hours for the City-wide park system; reiterated sound abatement system helped with the noise; acknowledged that it would never get rid of all of the noise; requested on behalf of many retirees who like to play at 8 A.M. and many working young people who like to play until 10pm and it is reasonable based on the money that is spent by the City to have the hours returned to normal municipal hour; acknowledge the compromise mentioned by Mr. Goldstein; discussed resurfacing the court like all other municipalities have done around Culver City with a kitchen.

Steve Mitsunaga discussed living in Culver City; moving to Culver City because of the paddle tennis courts; requested from a traditional perspective keep the times from 8 A.M.-10 P.M.; reminded players that they need to keep the sound down; mentioned he had a senior group that played at 8 A.M.; apologized to Mr. Goldstein for the early start and mentioned he respected his wishes; acknowledged that there are players who would try and play at 7:30 A.M.; believed 8 o'clock is not a bad time because it starts to get too hot to play; acknowledged that closing earlier, such as 9:30 or 9:45 is not bad because most people are in bed by 10 o'clock.

Discussion ensued between staff and Commissioners regarding past Ad Hoc subcommittees regarding racket sports; the timeline and staffing of locking the courts at night and opening them in the morning; the number of people who use the courts; the hours and availability of other courts in Culver City; the noise made by the players and the community responsibility of the players to reduce that noise; the daily use of the courts; the consideration of a compromise for the hours to close at different times and open at different times depending on the day of the week; the need for more locations; the newly installed sound barriers; confirmation that the bleachers are part of park property; how the summer and fall weather forces people to play earlier; proof that all ages play pickleball; the need for more clear signage or temporary sound signage; the original discussion that the court hours would return to their regular hours based on the sound barrier; how the success of the sound barrier is defined; coming to the end of what would be considered "temporary" for the hours; requesting staff to periodically make their way to the courts and remind players the rules on amplified sound; consideration of slowly expanding the hours instead of increasing them quickly.
