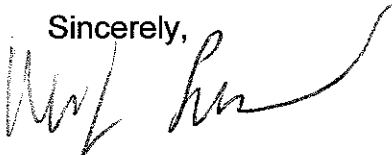
Dear Mayor and Members of the City Council:
