1 2. That the names of persons voted for at the election for Member of the
2 City Council are as follows: D. Scott Malsin, Mehaul O'Leary, and Gary Silbiger.

3 That the name of the person voted for at the election for City Clerk was
4 Christopher Armenta.

5 3. That the measure voted upon at the election is as follows:

6 Measure V: "Shall the Revised and Reorganized Charter of the City of
7 Culver City, as set forth in the Proposed Measure, be Adopted?"
8

9 4. That the number of votes given at each precinct and the number of
10 votes given in the City to each of the persons above named for the respective office to
11 which the persons were candidates are as listed in Exhibit "A".

12 5. That the number of votes given at each precinct and the number of
13 votes given in the City to the measure above named is listed in Exhibit "A".
14

15 6. That the City Council does declare and determine that D. Scott Malsin
16 was elected as Member of the City Council for the full term of four years; and Gary Silbiger
17 was elected as Member of the City Council for the full term of four years.

18 7. That the City Council does declare and determine that Christopher
19 Armenta was elected as City Clerk for the full term of four years, subject to terms of
20 Section 2010 of the revised City Charter, as adopted by Measure V, which upon its
21 effective date, provides that the person elected to the office of City Clerk at the April 11,
22 2006, general municipal election shall serve until April 8, 2008.

24 8. That as a result of the election, a majority of voters voting on Measure
25 V did vote in favor of it, and that the measure was carried, and shall be deemed adopted
26 and ratified.
27

1 9. That the City Clerk shall enter on the records of the City Council of the
2 City of Culver City, a statement of the result of the election, showing: (1) the whole number
3 of ballots cast in the City; (2) the names of the persons voted for; (3) the measure voted
4 upon; (4) for what office each person was voted for; (5) the number of votes given at each
5 precinct to each person, and for and against the measure; and (6) the total number of
6 votes given to each person; and for and against the measure.

7
8 10. That the City Clerk shall immediately make and deliver to each of the
9 persons so elected a Certificate of Election signed by the City Clerk and authenticated; the
10 City Clerk shall also administer to each person elected the Oath of Office prescribed in the
11 Constitution of the State of California and shall have them subscribe to it and file it in the
12 Office of the City Clerk. Each and all of the persons so elected shall then be inducted into
13 the respective office to which they have been elected.

14
15 11. That the City Clerk shall immediately file the complete text of Measure
16 V, the revised City Charter, adopted by the voters with the California Secretary of State.

17 12. That the City Clerk shall certify to the passage and adoption of this
18 resolution and enter it into the book of original resolutions.
