<u>RECOMMENDATION:</u> Staff recommends the City Council appoint Elena Sweda-Neff to the position of Culver City's Trustee on the Board of Trustees of the Los Angeles County West Vector Control District to fill the remainder of a two-year term ending December 31, 2010 and for the two-year term beginning January 1, 2011 and ending December 31, 2012. <u>BACKGROUND:</u> The City of Culver City is entitled to appoint a representative (Trustee) to the Los Angeles County West Vector Control District. The Vector Control District is empowered to undertake and carry out a vast number of abatement and control duties under the California Health and Safety Codes pertaining to mosquito and vector control. This position was previously filled by Lupe Mercado with her term ending December 31, 2008. The position has been vacant since that time. The Trustee is required to be a resident and registered voter of the City. <u>DISCUSSION:</u> The City Clerk advertised for this position through November 15, 2010 and only one application was submitted, that of Elena Sweda-Neff. Mrs. Sweda-Neff is a resident of the City of Culver City and a registered voter as required.
