WHEREAS, a General Municipal Election was held and conducted in the City of San Jose, California, on Tuesday, April 13, 2010, as required by the Charter of the City of San Jose; and,

WHEREAS, the City Clerk, acting in the capacity of Elections Official as provided for in the Charter of the City of Culver City, canvassed the returns of the election and has certified the results to this City Council, which results are received, attached, and made a part hereof as Exhibits "A" and "B."

1. The whole number of ballots cast in the precincts except vote by mail ballot and provisional ballots was 2504. That the whole number of vote by mail voter ballots and the whole number of provisional ballots cast in the City was 2553, making a total of 5057 ballots cast in the City.

1 2. The names of persons voted for at the election for Member of the City
2 Council are as follows: Robert Zirgulis, Jeffrey Cooper, Meghan Sahli-Wells and D. Scott
3 Malsin.

4 3. The number of votes given at each precinct and the number of votes
5 given in the City to each of the persons above named for the respective office for which the
6 persons were candidates are as listed in Exhibit "A" attached hereto and made a part
7 hereof.

8 4. The City Council does declare and determine that D. Scott Malsin is
9 elected as a Member of the City Council for the full term of four years; and Jeffrey Cooper
10 is elected as Member of the City Council for the full term of four years.

11 5. The City Clerk shall enter on the records of the City Council of the City
12 of Culver City a statement of the result of the election, showing: (1) the whole number of
13 ballots cast in the City; (2) the names of the persons voted for; (3) the office into which
14 each person was voted; (4) the number of votes given at each precinct to each person; and
15 (5) the total number of votes given to each person.

16 6. The City Clerk shall immediately make and deliver to each of the
17 persons so elected a Certificate of Election signed by the City Clerk and authenticated.
18 The City Clerk shall also administer to each person elected the Oath of Office prescribed in
19 the Constitution of the State of California and shall have them subscribe to it and file it in
20 the Office of the City Clerk. Each and all of the persons so elected shall then be inducted
21 into the respective office to which they have been elected.

7. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.

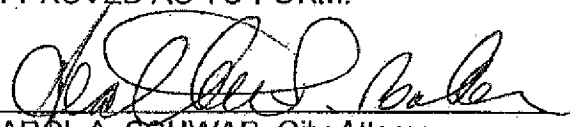

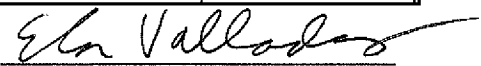
