



1           SECTION 2. The Board of Supervisors of the County of Los Angeles  
2 is hereby further respectfully requested to place upon the same ballot as that  
3 provided for said Statewide General Election to be held in the County of Los  
4 Angeles on November 3, 2026, the names of the candidates for the office of  
5 Council Member, with two seats available, each for a full four-year term, as well  
6 as a proposed ballot measure to be submitted to the voters of Culver City.

7           SECTION 3: That the Board of Supervisors of the County of Los  
8 Angeles is hereby authorized and respectfully requested to canvass the returns of  
9 the General Municipal Election. The election shall be held in all respects as if there  
10 were only one election, and only one form of ballot shall be used.

11           SECTION 4. That the Board of Supervisors is requested to issue  
12 instructions to the Registrar-Recorder/County Clerk of the County of Los Angeles  
13 to take any and all steps necessary for the holding of the consolidated election.

14           SECTION 5. That pursuant to the provisions of Section 10002 of the  
15 Elections Code, the City Council respectfully requests the Board of Supervisors of  
16 the County of Los Angeles to authorize and permit the Registrar-Recorder/County  
17 Clerk of the County of Los Angeles to:

18           a.     Print and supply ballots for said City of Culver City General  
19 Municipal Election;

20           b.     Mail the City's voter information guides and candidate  
21 statements of qualifications to the electors of the City of Culver City as part  
22 of the same material that will be mailed to the voters of the Statewide  
23 General Election to be held in the County of Los Angeles;

24           c.     Perform such other services as may be required for the  
25 consolidation and conduct of said City of Culver City General Municipal  
26 Election with said Statewide General Election to be held in the County of  
27 Los Angeles.

SECTION 8. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
