Vice Chair Goldhaber indicated nothing to report from the Ad Hoc Subcommittee Focused on the Arts For and By the Disabled; she proposed that the Equity and Human Relations Ad Hoc Subcommittee be dissolved as the mission had been fulfilled and that an alternative committee formed; and she discussed

consideration of forming an Ad Hoc Public Outreach and Public Relations Subcommittee to gain feedback from the community.

Melanie Morales, Recreation and Community Services Coordinator, stated that the changes should be agendized at the next meeting to ensure transparency.

Discussion ensued between staff and Committee Members regarding Brown Act rules; difficulty interacting with other CBCs; formation of a committee of CBC members; the e-comment received in support of having a day to interact with other CBCs; frequency of meetings; length of time it takes to accomplish things; other bodies that meet on a monthly basis; the City budget; requesting that the City Council allow the DAC to meet on a monthly basis; clarification that the agenda item is focused on appointing or reappointing subcommittee members rather than on receiving updates; the need to recommend a resolution to change the bylaws for City Council approval in order to change meeting frequency; consultation with the City Clerk; review of the bylaws to consider any potential changes; formation of a broader reaching subcommittee; interaction with other CBCs in the City; current subcommittee assignments; the Equity and Human Relations Advisory Committee (EHRAC); the need for ad hoc subcommittees to dissolve when their mission has been fulfilled; two Members who want to drop off of the Ad Hoc Subcommittee Focused on the Arts For and By the Disabled; the ability of new Members to join subcommittees; and Committee consensus was achieved to agendize consideration of dissolving and creating subcommittees at the October meeting.


