Over the past year she has demonstrated an unwavering commitment to excellence and dedication to our team's success. Through her tireless efforts and remarkable skillset, Maggie has significantly contributed to the advancement of the Geographical Information Systems (GIS) projects and initiatives. She worked extensively to provide enhanced data management by collaborating with the Los Angeles County Assessor's Office to better understand, translate and manage the City's Parcel data. Her work also including working with the Planning Division to coordinate numerous property address updates.
