**Action Items**

Item A-1

**CAC - (1) Consideration of the Deaccession of a Permanent Public Artwork Located at 12211 W. Washington Boulevard**

Christine Byers, Cultural Affairs Coordinator, introduced the item and provided a summary of the material of record.

Dianne Shapiro, Abramson Teiger, presented the case for deaccessioning the artwork and she discussed in-lieu fees paid to the Cultural Arts Trust Fund.

Chair Dickter invited public comment.

Christine Byers, Cultural Affairs Coordinator, reported on public noticing for the deaccession and read comments submitted by:

Stephen Quinn

Christine Byers, Cultural Affairs Coordinator, clarified that the proposal was to remove the wave and chain link elements; noted that the signage installation near the roofline would provide better visibility for passing vehicles; discussed communication with Mr. Quinn; and she noted that the components comprising the artwork would be disposed of.

Discussion ensued between Ms. Shapiro, staff and Commissioners regarding retention of the corrugated element around the roofline of the building; removal of the sail and wave elements; retention of the main corrugated strip with signage placed on top of that; proposed signage location; clarification that no rooftop signage is proposed; the Master Sign program; approvals; current tenants; important connections between the community and the art; acknowledgement that deaccessioning is not to be taken lightly; payment back into the Cultural Trust Fund;

and appreciation for the work of the CAC Public Art Subcommittee.

MOVED BY COMMISSIONER WILLIAMS AND SECONDED BY COMMISSIONER FLEISCHER THAT THE CULTURAL AFFAIRS COMMISSION APPROVE THE REQUEST BY WEST WASHINGTON INVESTORS LP TO DEACCESSION AN ARTWORK BY ANDREA COHEN GEHRING (THREE SHEETS TO THE WIND) ORIGINALLY COMMISSIONED UNDER THE CITY'S ART IN PUBLIC PLACES PROGRAM FOR THE PROPERTY LOCATED AT 12211 W. WASHINGTON BOULEVARD.

Christine Byers, Cultural Affairs Coordinator, reported that the City Council had unanimously approved the Innovation Plan for The Culver Studios; she indicated that there would be a mid-year work plan update at the February Commission meeting,

and a presentation on proposed FY 2018-19 work plan and budget priorities at the March Commission meeting; reported that the Artist Laureate item would be presented at the February 12 City Council meeting; and she announced a special Cultural Affairs Foundation Board meeting on January 25, noting that if the revised bylaws and amended structure for the Foundation is supported by the Foundation Board, it will also go before the City Council on February 12.

Louise Coffey-Webb, Public Art Collections Manager, provided a presentation on maintenance and repairs of certain artworks commissioned under the Art in Public Places Program.

Chair Dickter received clarification regarding the *Soleil* piece and he expressed appreciation for the update.

Christine Byers, Cultural Affairs Coordinator, indicated that the City would be updating the Cultural Plan.

Commissioner Fleischer wished everyone a Happy New Year and announced a free upcoming concert at Loyola Marymount University on January 28 that makes classical music accessible to young people by adding other media.

Chair Dickter reported that he would be joining the Los Angeles County Arts Commission on February 2 for the final meeting on the Vermont Avenue Probation Office project; announced that Heidi Duckler would be hosting the Ebb & Flow event at the Baldwin Hills Overlook on February 3; he indicated that he and staff would present a keynote on the Creative Economy of Culver City to the faculty and staff at West Los Angeles College on February 9 followed by a further conversation at an April event; and he reminded everyone that the City Council would be voting on the Artist Laureate Program on February 12 as well as possible changes to the structure of the Culver City Cultural Affairs Foundation.


