<u>RECOMMENDATION:</u> Staff recommends the City Council adopt a resolution: 1. Approving the Engineer's Report for the Landscape Maintenance District Number 1 (LMD #1) - Fiscal Year 2014/2015; 2. Declaring its Intention to Order the Levy of Annual Assessments for Fiscal Year 2014/2015; and, 3. Setting a Public Hearing for June 23, 2014, at 7:00 p.m. in the Mike Balkman Council Chambers. <u>BACKGROUND/DISCUSSION:</u> LMD #1 consists of homes in Studio Estates and was created for the purpose of providing on-going maintenance of landscaping located in the area between the sidewalk and wall adjacent to Culver Boulevard and Elenda Street. The assessment includes costs for providing complete maintenance, administration, and preparation of the annual Engineer's Report. Pursuant to a Resolution adopted by the City Council on Monday, May 12, 2014, the Public Works Director/City Engineer has prepared the Engineer's Report for LMD #1 and filed said Report with the City Clerk. A copy of the Engineer's Report is attached for consideration by the City Council.

For Fiscal Year 2014/2015, staff is recommending no increase in the assessment levy.

This evening, the City Council is asked to adopt a resolution (1) approving the Engineer's Report, (2) declaring the City Council's intention to levy and collect assessments for the upcoming fiscal year; and (3) setting the time and place for the public hearing as required by Culver City Municipal Code (CCMC) Section 15.01.070.

Should the City Council adopt the proposed resolution, pursuant to 15.01.070(G) of the CCMC, the City Clerk shall give notice of the public hearing by causing the Resolution of Intention to be published at least 10 days prior to the date of the hearing. The public hearing is scheduled for June 23, 2014.
