RESOLUTION NO. 2025-SA 1 2 A RESOLUTION OF THE BOARD OF DIRECTORS OF THE 3 SUCCESSOR AGENCY TO THE CULVER CITY REDEVELOPMENT AGENCY APPROVING ADMINISTRATIVE BUDGETS FOR THE 4 PERIODS JULY 1, 2025 THROUGH DECEMBER 31, 2025 AND JANUARY 1, 2026 THROUGH JUNE 30, 2026, AND APPROVING 5 CERTAIN RELATED ACTIONS. 6 7 WHEREAS, the former Culver City Redevelopment Agency ("Former CCRA") 8 was a redevelopment agency in the City of Culver City ("City"), duly created pursuant to the 9 California Community Redevelopment Law (Part 1 (commencing with Section 33000) of 10 Division 24 of the California Health and Safety Code) ("Redevelopment Law"); and 11 WHEREAS, the former CCRA was responsible for the administration of 12 redevelopment activities within the City; and 13 WHEREAS, Assembly Bill No. X1 26 (2011-2012 1<sup>st</sup> Ex. Sess.) ("AB 26") was 14 signed by the Governor of California on June 28, 2011, making certain changes to the 15 Redevelopment Law and the California Health and Safety Code ("Health and Safety Code"), 16 including adding Part 1.8 (commencing with Section 34161) ("Part 1.8") and Part 1.85 17 (commencing with Section 34170) ("Part 1.85") to Division 24 of the Health and Safety Code; 18 and 19 WHEREAS, pursuant to AB 26, as modified by the California Supreme Court 20 on December 29, 2011 by its decision in California Redevelopment Association v. 21 Matosantos, all California redevelopment agencies, including the former CCRA, were 22 dissolved on February 1, 2012, and successor agencies were designated and vested with 23 the responsibility of paying, performing and enforcing the enforceable obligations of the 24 former redevelopment agencies and expeditiously winding down the business and fiscal 25 affairs of the former redevelopment agencies; and 26

WHEREAS, the City Council of the City adopted Resolution No. 2012-R001 on January 9, 2012, pursuant to Part 1.85 of AB 26, electing for the City to serve as the

1 successor agency to the Former CCRA upon the dissolution of the Former CCRA under AB 26 ("Successor Agency"); and 2

WHEREAS, on February 6, 2012, the Board of Directors of the Successor Agency (the "Successor Agency Board"), adopted Resolution No. 2012-SA001 naming itself the "Successor Agency to the Culver City Redevelopment Agency", the sole name by which it will exercise its powers and fulfill its duties pursuant to Part 1.85 of AB 26, and establishing itself as a separate legal entity with rules and regulations that will apply to the governance and operations of the Successor Agency; and

9 WHEREAS, as part of the FY 2012-2013 State budget package, on June 27, 2012, the Legislature passed and the Governor signed Assembly Bill No. 1484 ("AB 1484", 10 Chapter 26, Statutes 2012). Although the primary purpose of AB 1484 is to make technical and substantive amendments to AB 26 based on issues that have arisen in the 12 13 implementation of AB 26, AB 1484 imposes additional statutory provisions relating to the 14 activities and obligations of successor agencies and to the wind down process of former 15 redevelopment agencies; and

16 WHEREAS, on September 23, 2015, the Legislature passed and the Governor signed Senate Bill No. 107 ("SB 107", Chapter 325, Statutes of 2015). SB 107 imposed 17 further statutory provisions relating to the wind down process of former redevelopment 18 agencies, including extending the Recognized Obligation Payment Schedule period from six 19 months to a full fiscal year; and 20

WHEREAS, AB 26 as amended by AB 1484 and SB 107 are collectively 21 referred to hereinafter as the "Dissolution Act"; and 22

23 WHEREAS, Health and Safety Code Section 34179 of AB 26 as amended by the Dissolution Act established a seven (7) member local entity with respect to each 24 successor agency and such entity was titled the "oversight board." The oversight board was 25 established for the Successor Agency (hereinafter referred to as the "Oversight Board") and 26 all seven (7) members were appointed to the Oversight Board pursuant to Health and Safety 27

Code Section 34179. The duties and responsibilities of the Oversight Board are primarily set forth in Health and Safety Code Sections 34179 through 34181 of the Dissolution Act; and 2

WHEREAS, pursuant to Health and Safety Code Section 34179(q), commencing on and after July 1, 2018, the County of Los Angeles, where more than 40 oversight boards were created by the Dissolution Act, shall have five consolidated oversight boards each encompassing the five supervisorial districts; and

WHEREAS, the Second District Consolidated Oversight Board (hereinafter referred to as "Oversight Board") has jurisdiction over the Successor Agency; and

WHEREAS, Health and Safety Code Section 34177(j) of the Dissolution Act requires the Successor Agency to prepare an administrative budget for each six-month fiscal period and submit the administrative budget to the Oversight Board for approval. The administrative budget shall include all of the following: (i) estimated amounts for Successor 12 13 Agency administrative costs for the upcoming six-month fiscal period; (ii) proposed sources 14 of payment for Successor Agency administrative costs; and (iii) proposals for arrangements 15 for administrative and operations services provided by the City or other entity; and

16 WHEREAS, Health and Safety Code Section 34177(k) of the Dissolution Act 17 requires the Successor Agency to provide to the Los Angeles County Auditor-Controller ("County Auditor-Controller") for each six-month fiscal period the administrative cost 18 estimates from its approved administrative budget that are to be paid from property tax 19 revenues (i.e., former tax increment revenues) deposited in the County's Redevelopment 20 21 Property Tax Trust Fund established for the Successor Agency; and

WHEREAS, staff of the Successor Agency seeks the Successor Agency's 22 approval of the administrative budgets for the periods of July 1, 2025 through December 31, 23 2025 ("Administrative Budget 25-26A") and January 1, 2026 through June 30, 2026 24 ("Administrative Budget 25-26B"), in the forms attached to this Resolution as Exhibit "A", and 25 the Successor Agency's authorization to submit the approved Administrative Budgets 25-26 26A and 25-26B (collectively, "Administrative Budget 25-26") to the Oversight Board for its 27

approval and to forward the information required by Health and Safety Code Section 34177(k) to the County Auditor-Controller; and

WHEREAS, the Administrative Budget 25-26 has been prepared in accordance with Health and Safety Code Section 34177(j) of the Dissolution Act and is consistent with the requirements of the Health and Safety Code and other applicable law. The proposed source of payment of the costs set forth in the Administrative Budget 25-26 is from property taxes from the County's Redevelopment Property Tax Trust Fund established for the Successor Agency; and

WHEREAS, as required by Health and Safety Code Section 34180(j) of the Dissolution Act, the Successor Agency will submit a copy of the Administrative Budget 25-26 to the County Administrative Officer, the County Auditor-Controller, and the Department of Finance at the same time that the Successor Agency submits the Administrative Budget 25-26 to the Oversight Board for review and approval; and

WHEREAS, as required by Health and Safety Code Section 34179(f) of the Dissolution Act, all notices required by law for proposed actions of the Oversight Board will be posted on the Successor Agency's internet website or the Oversight Board's internet website; and

WHEREAS, pursuant to Health and Safety Code Section 34179(h) of the Dissolution Act, the Successor Agency is required to provide written notice and information about all actions taken by the Oversight Board to the Department of Finance by electronic means and in the manner of the Department of Finance's choosing; and

WHEREAS, in furtherance of Part 1.85 of the Dissolution Act, a copy of the Administrative Budget 25-26 as it may be approved by the Oversight Board will be submitted to the County Auditor-Controller and both the State Controller's Office and the Department of Finance and will be posted on the Successor Agency's internet website; and

WHEREAS, pursuant to Health and Safety Code Section 34183(a)(2) of the Dissolution Act, the County is required to make a payment of property tax revenues (i.e., former tax increment funds) to the Successor Agency on June 1, 2025 and January 2, 2026 for payments to be made toward recognized obligations listed on the ROPS 25-26 and for the administrative cost estimates from its approved Administrative Budget 25-26; and

WHEREAS, the activity proposed for approval by this Resolution has been reviewed with respect to applicability of the California Environmental Quality Act ("CEQA"), the State CEQA Guidelines (California Code of Regulations, Title 14, Section 15000 *et seq.*, hereafter the "Guidelines"), and the City's environmental guidelines; and

WHEREAS, the activity proposed for approval by this Resolution is not a "project" for purposes of CEQA, as that term is defined by Guidelines Section 15378, because this Resolution is an organizational or administrative activity that will not result in a direct or indirect physical change in the environment, per Section 15378(b)(5) of the Guidelines; and

WHEREAS, all of the prerequisites with respect to the approval of this Resolution have been met.

NOW, THEREFORE, the Board of Directors of the Successor Agency to the Culver City Redevelopment Agency, DOES HEREBY RESOLVE as follows:

SECTION 1. The foregoing recitals are true and correct and are a substantive part of this Resolution.

SECTION 2. The adoption of this Resolution is not intended to and shall not constitute a waiver by the Successor Agency of any constitutional, legal or equitable rights that the Successor Agency may have to challenge, through any administrative or judicial proceedings, the effectiveness and/or legality of all or any portion of AB 26, AB 1484 and/or SB 107, any determinations rendered or actions or omissions to act by any public agency or government entity or division in the implementation of AB 26, AB 1484 and/or SB 107, and any and all related legal and factual issue, and the Successor Agency expressly reserves any and all rights, privileges, and defenses available under law and equity.

SECTION 3. The Successor Agency Board hereby approves and adopts Administrative Budget 25-26A for the period covering July 1, 2025 through December 31, 2025 and Administrative Budget 25-26B for the period covering January 1, 2026 through June 30, 2026, substantially in the forms attached to this Resolution as Exhibit "A".

SECTION 4. The Executive Director, or designee, is hereby authorized and directed to: (i) submit the approved Administrative Budget 25-26 to the Oversight Board for its review and approval and concurrently submit a copy of the Administrative Budget 25-26 to the County Administrative Officer, the County Auditor-Controller, and the Department of Finance; (ii) submit the Administrative Budget 25-26, as approved by the Oversight Board, and written notice of the Oversight Board's approval of the Administrative Budget 25-26, to 10 the Department of Finance (electronically) pursuant to Health and Safety Code Section 34179(h) of AB 26 as amended by AB 1484; (iii) submit a copy of the Administrative Budget 12 13 25-26, as approved by the Oversight Board, to the County Auditor-Controller and the State 14 Controller's Office; (iv) post the Administrative Budget 25-26, as approved by the Oversight 15 Board, on the Successor Agency's internet website; (v) upon approval of the Oversight Board, submit to the County Auditor-Controller the administrative cost estimates from the 16 Administrative Budget 25-26 that are to be paid from property tax revenues deposited in the County's Redevelopment Property Tax Trust Fund established for the Successor Agency; 18 and (vi) take such other actions and execute such other documents as are necessary to 19 effectuate the intent of this Resolution on behalf of the Successor Agency. 20

SECTION 5. The staff of the Successor Agency are hereby authorized and 21 directed, jointly and severally, to do any and all things which they may deem necessary or 22 advisable to effectuate this Resolution. 23

SECTION 6. The Successor Agency Board determines that the activity 24 approved by this Resolution is not a "project" for purposes of CEQA, as that term is defined 25 by Guidelines Section 15378, because the activity approved this Resolution is an

7	Successor Agency Board declares that it would have adopted this Resolution irrespective of					
8	the invalidity of any particular portion of this Resolution.					
9	SECTION 8. This Resolution shall take effect immediately upon its adoption.
