3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 CULVER CITY, CALIFORNIA, APPROVING A FINAL
5 ENGINEER'S REPORT AND CONFIRMING THE
6 ASSESSMENT AND ORDERING THE LEVY FOR THE
7 SEWER USER'S SERVICE CHARGES FOR FISCAL YEAR
8 2020-2021.

9 WHEREAS, the City Council previously completed proceedings in
10 accordance with the provisions of Chapter 5.02 of the Culver City Municipal Code
11 ("CCMC") for the levy and collection of annual assessments for the system of sewer
12 user's service charges providing that each parcel of property shall pay its proportionate
13 share of the costs for operation, maintenance, repair and improvements of the City
14 sewerage system (the "Sewer User's Service Charges"); and,

15 WHEREAS, on May 26, 2020, the City Council preliminarily approved the
16 Assessment Engineer's Report (the "Engineer's Report") and declared its intention to
17 provide for the levy and collection of annual assessments for Fiscal Year 2020-2021, to
18 provide for the costs and expenses necessary for the operation, maintenance, repair
19 and improvements of the City sewerage system; and,

20 WHEREAS, the City Council has heard all testimony and considered all
21 objections to the assessment at a duly noticed public hearing held on June 8, 2020 and
22 has determined to proceed with the levy of annual assessments for the District.

23 NOW, THEREFORE, the City Council of the City of Culver City, DOES
24 HEREBY RESOLVE as follows:

26 1. The City Council hereby confirms the allocation of levy amounts
27 and assessment as is described in full detail in the Engineer's Report.

1 2. The adoption of this resolution shall constitute the levy of an
2 assessment for the fiscal year commencing July 1, 2020 and ending June 30, 2021.

3 3. The assessment for the Sewer User's Service Charges as set forth
4 in the Engineer's Report shall be performed pursuant to law. The County Auditor shall
5 enter on the County Assessment Roll the amount of the assessment and the
6 assessment shall be collected at the same time and in the same manner as the County
7 property taxes are collected. After collection by the County, the net amount of the
8 assessment shall be paid to the City of Culver City.

10 4. Upon receipt of monies representing assessments collected by the
11 County, the City shall deposit the monies into a special fund known as the "Fund for
12 Sewer User's Service Charges" which was previously established upon the creation of
13 the District.

15 5. Immediately upon the adoption of this Resolution, the City Clerk
16 shall file a certified copy of this Resolution, which includes the Engineer's Report
17 containing the allocation of levy amounts and assessment, with the County Auditor.
